What you need to know

Notes

- a) Failure to supply information requested in this form may prevent the registration of your dog. You must notify Auckland Council of any change of address or change in ownership of the dog(s).
- b) For the purposes of the Dog Control Act 1996 (the Act), you are the owner of a dog if (a) you own the dog; or (b) you have the dog in your possession (unless you have the dog for less than 72 hours to prevent the dog causing injury, damage or distress or to return a lost dog to its owner); or (c) you are the parent or guardian of a person under 16 years who is the owner of the dog and who is a member of your household living with and dependent on you. A person aged under 16 years cannot be the registered owner of a dog.
- c) Your date of birth is required by the Act; it enables us to distinguish you from other persons with the same name.
- d) You must provide evidence of neutering, as stated in the enclosed information.
- e) The types of registration class and types of dog eligible to be classed as a working dog are listed in the enclosed information.
- f) Classified as menacing; means classified as a menacing dog under section 33A or section 33C of the Act. Classified as dangerous; means classified as dangerous dog under section 31 of the Act.
- g) Fees are inclusive of GST. If your dog is less than three months old on or after the 2 August or arrives in New Zealand after 2 August you pay a portion of the annual registration fee. Please call 09 301 0101 for the correct fee.
- h) To be eligible for the Superannuitant's SuperGold Community Services card rate, you must present your SuperGold Community Services card with the notation CSC in person at a service centre. (See note 5 on the information sheet).

Important Privacy Information

Your information will be held and used solely for purposes of the Act. Section 35 of the Act allows any person to apply in writing for the name and address of the owner of any specified dog. Council is required to provide that information where it is satisfied of that person's identity and that the information is required for one of a limited number of purposes specified in section 35(5), such as returning a lost dog to its owner or seeking compensation for damage.
