1. Monthly Financial Statements

The statements of Financial Position and Performance for ACIL Parent for the period from 1 July 2017 to 31 March 2018 are **attached**.

The main variances between the actual financial results for YTD 31 March 2018 and the budgets with comments are outlined below:

a) POAL paid its interim dividend of \$23.8 million in February 2018. YTD total dividend income received from POAL is \$49.9 million, which is \$11.6 million higher than the budget mainly due to a \$14.5 million unplanned tax benefit included in the actual dividend payment. The total dividend income from POAL for the year excluding the tax benefit is \$35.3 million, which is \$2.9 million lower than the full year budget.

AIAL paid a final dividend of \$28 million to ACIL in October 2017, which is \$0.8 million higher than the ACIL's YTD budget (which was 10.2 cents per share based on brokers' reports in January 2017). AIAL has announced its interim dividend of 10.75 cent for the 2017/18 year, which will be paid to shareholders on 5 April 2018. Total dividend income from AIAL for the year will be \$56.6 million, which is \$2.3 million higher than the full year budget.

Total dividend income from POAL and AIAL for the 2017/18 year will be \$106.5 million, being \$14 million higher than the full year budget.

- b) Consultancy fees are less than YTD budget as expenses will come through later in the year. Other YTD operating expenses are close to budget.
- c) The AIAL share price has declined from \$7.13 (30 June 2017) to \$6.12 (31 March 2018), a decrease of \$269m in market value for the last nine months. There is a decrease in value of \$32 million from 31 May 2016 to 31 March 2018, which will be recognised using the equity method in the consolidated financial statements (December and June accounts).



1. Statistics

The Auckland Airport monthly traffic updates showing domestic and international statistics for the passenger movements and the Maximum Certified Take-Off Weight (MCTOW) for January and February 2018 are **attached**.


Chinese visitor arrivals were up 92.1% in February compared with the previous year due to the later timing of the Chinese New Year. The Chinese visitor arrivals were down 28.4% in January compared with the previous year for the same reason. The combined January and February arrivals were up 19.1% compared with the same months last year.


The airport achieved a new daily international passenger record, with 39,557 passengers travelling through it on Saturday 6 January. In January, international passengers averaged 33,026 per day which is an average increase of 1,080 per day on the previous year. The airport also exceeded 1 million passengers for the second consecutive month in January.

January 2018 Monthly traffic update

- **1 million** For the second consecutive month, Auckland Airport welcomed a record number of international passengers. The 1,023,798 international passengers (excluding transits) in January 2018 was 10,000 more than the previous record set in December 2017 – and 3.4% more than in January 2017. This strong start to the second half of the 2018 financial year was driven by additional seats on the Asia and Middle East routes (+43,000), Americas (+18,000) and the Pacific Islands (+12,000).
 - **39,557** A new daily international passenger record was achieved at Auckland Airport on Saturday 6 January 2018, with 39,557 international passengers travelling through the international terminal. In January 2018, international passengers averaged 33,026 per day, an average increase of 1,080 per day compared to January 2017.
- -28.4% In January 2018 Auckland Airport's Chinese visitor arrivals were down 28.4% compared to January 2017. This was driven by the later timing of Chinese New Year (February this year compared to January last year). In the past year Auckland Airport has seen strong growth in New Zealand residents travelling to China, up 13.2%. This growth was stimulated by a 10.7% increase in seat capacity between Auckland and mainland China.
- **200,000** Queenstown Airport achieved double-digit passenger growth (up 10.8%) and over 200,000 total passengers in January 2018. Domestic passenger performance at Queenstown Airport was up 10.9% in January 2018, driven by new seat capacity (+10,000) and strengthening passenger numbers on the Auckland–Queenstown route.

6.5% International passengers (excluding transit passengers) increased by 6.5% to 872,408 in February 2018. The 53,000 increase compared with February 2017 was due to Chinese New Year travel falling in mid-February this year compared to January last year, and strong growth in the number of New Zealanders travelling overseas (up 7.2%) as a result of increased capacity on the Asia and Middle East routes (up 13.6%) and the Americas (up 9.2%).

EK Bali

In February 2018, Emirates announced a new daily service from Dubai to Auckland via Bali, commencing June 2018. This service will complement the airline's existing non-stop daily service between Dubai and Auckland and provide the only year-round daily service between Auckland and Bali. Emirates and Qatar Airways, which operates a daily Doha-Auckland service, have increased New Zealand's connectivity to Europe, with European resident arrivals up 8.6% in the past 12 months.

19.1% The later timing of Chinese New Year this year resulted in a 92.1% increase in Chinese visitor arrivals in February 2018, compared with February 2017. The combined January and February 2018 Chinese visitor arrivals were up 19.1% compared with the same months last year. Taiwanese visitor arrivals also experienced the same trend over the same period, up 22.0%.

A new direct service to Taipei was announced by Air New Zealand in February 2018. Commencing in November 2018, the new service is expected to add an additional 95,000 seats to the route every year. China Airlines' daily Taipei-Auckland service operates via Brisbane and the introduction of a direct service is expected to increase the popularity of New Zealand as a holiday destination.
