- 3.3.2. Is it appropriate to retain the additional public places and extent of sunlight admission (Figures 10-16) identified in "Appendix 11 Business – City Centre Zone sunlight admission into public places" as notified?

Note: Figures 10-16 in Appendix 11 were notified as new content in PC78.

- a) The following experts consider that figures 10-16 in Appendix 11 should be subject to further modelling and assessment, (such as time, dates and spatial extent for sunlight admission protection), including assessment against s77O(j) and s77R to determine if they are appropriate to be retained and / or modified: Karl Cook, Nick Roberts, Rachel de Lambert, John McCall, Cam Wallace, Graeme McIndoe, Doug Fairgray, David Haines, Elisabeth Laird, Peter Kensington, Sheerin Samsudeen, Severin Soder, Ezra Barwell, and Howell Davies.

 - b) The following experts consider that it is <u>not</u> appropriate that the special information requirement "H8.10.1. Alterations and additions to buildings identified as historic heritage and special character" (conservation plans and character plans) be included in PC78: John McCall, Clare Covington, and Karl Cook.
 - c) The following experts are neutral on this matter: Alice Morris, Cam
 Wallace, Mark Benjamin, and Evan Keating.

3.6. Additional matters

Note: The experts have identified that there is a difference in interpretation as to whether building heights and density of urban form can be modified 'to maximise benefits of intensification' in NPS-UD Policy 3(a) separately from the application of Policy 4 qualifying matters.
