## 12 Inter-Council Working Party Meeting on Genetically Modified Organisms, 30 January 2013

Resolution number ES/2013/4

MOVED by Cr W Walker, seconded Cr C Casey:

#### That the Environment and Sustainability Forum:

- a) receive and supports in principle the resolutions of the Inter Council Working Party (ICWP) on GMO Risk Evaluation and Management Options as set out in the minutes of the meeting of the ICWP on 30 January 2013.
- b) recommend that the Auckland Plan Committee:
  - (i) further develop Unitary Plan provisions for the management of the outdoor use of genetically modified organisms, taking into account the documentation from the ICWP and based on the feedback received during the informal feedback period of the draft Unitary Plan;
  - (ii) consider the full documentation of the ICWP as found in the attachment (c) to Item 12 of the 19 February 2013 Environment and Sustainability Forum Agenda (attachment under separate cover), also available on request.
  - (iii) consider the Draft Proposed Plan Provisions and Draft Section 32
    Report as produced by the ICWP for inclusion in its Unitary Plan, and
    that Auckland Council acknowledges the importance of a collaborative
    approach with other member councils on the ICWP to support the
    effectiveness of the draft proposed plan provisions and the efficiencies
    to be gained by sharing the costs of future statutory processes (where
    possible), including joint response to possible legal challenge.
- c) recommend that the Regional Development and Operations Committee:
  - (i) consider the full documentation of the ICWP as found in the attachment

- (c) to Item 12 of the 19 February 2013 Environment and Sustainability Forum Agenda (attachment under separate cover), also available on request.
- (ii) agree, subject to the ICWP member councils' determinations in respect to recommendation (e) from the minutes of the ICWP meeting on 30 January 2013, that a memorandum of understanding between the participating councils to jointly manage any further statutory process, including response to possible legal challenge, be prepared and provide for the joint funding of that process, where possible (on an equitable basis as used for previous work).
- (iii) agree, prior to signing a memorandum of understanding, that a process be developed to enable co-ordination between participating councils in respect of statutory procedures (and timing) concerning the introduction of plan provisions into planning documents for managing the outdoor uses of GMOs.
- d) note that the plan provisions and accompanying Section 32 Report are in draft and will not be final until such time as they are publically notified as a change to, or introduction of, a district or unitary plan, and that new information and/or consultation which may occur in the intervening period may be considered in the documentation.
- e) request that officers, in collaboration with the ICWP, provide a report back to the Forum on the management of the outdoor use of genetically modified organisms and Auckland Council's possible roles, including the following matters:
  - (i) the findings and recommendations of the report of the ICWP on GMO Risk Evaluation and Management;
  - (ii) Auckland Council's role in the context of the national regime for management of genetically modified organisms;
  - (iii) a review of the existing legal opinions on the management of genetically modified organisms;
  - (iv) risk and liability issues, including the implications of doing nothing and having a formal policy.
