## **HEARING DIRECTION #1 FROM THE HEARING PANEL**

  - (c) Apply the Stormwater Management Area Flow 1 Overlay over whole plan change area.
- 3. Before the hearing timetable is set down, the Chair directs the applicant to file a memorandum outlining what, if any, changes they recommend to the proposal and outline which changes are in response to which submissions. This memorandum should be lodged with the Council's Hearings Advisor, Sidra Khan, by 5pm, Friday 25 August 2023.
- 4. The reason for this is, in accordance with Part 2 of Schedule 1 of the RMA, any modifications to the plan change application must be made prior to the Local Authority considering the request under S25 of Schedule 1. As this private plan change has already been notified, the S42A report will be based on the private plan change as notified. The chair, in setting the hearing timetable, will take into consideration the extent of any proposed changes to ensure all parties have sufficient time to prepare for the hearing.

## MAY IT PLEASE THE HEARINGS PANEL

- The Hearing Panel's Direction Number 1, dated 17 August 2023, directed the Applicant to file a memorandum outlining what, if any, changes it recommends to Plan Change 91 to the Auckland Unitary Plan (Operative in Part) ("PC91") and to outline which changes are in response to which submissions. This memorandum responds to the Hearing Panel's Direction Number 1.
- 2. The Applicant confirms that it does not, at this time, recommend any changes to PC91 as notified. Its preference is to first receive and review the Auckland Council Reporting Planner's Section 42A Report and recommendation to the Hearing Panel, which will include a comprehensive assessment of PC91 as notified and submissions received in relation to it.
