- (b) **The applicant** is required to provide all its briefs of evidence by 12 noon on **Friday 17 September 2021.** You will be advised once the evidence is available.
  - The commissioners have directed that the applicant provide any rebuttal evidence by **12 noon on Wednesday 29 September 2021** and have requested their legal submissions at the same time. You will be advised once they are available.
- (c) Any submitter proposing to call expert witnesses is required to provide briefs of their evidence by 12 noon Friday 24 September 2021. An expert is a professional such as a planner, traffic engineer or similar.
  - Submitter non-expert evidence and legal submissions have been requested to be provided by 12 noon on Friday 24 September 2021

The commissioner have requested that any submitter legal submissions be provided by 12 noon on Wednesday 29 September 2021

The submitter is required to provide:

- 10 hard copies of the evidence
- 1 soft copy briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.
