Please note the commissioners will carry out a site visit, individually or together, either before, during or after the hearing which may involve them going on to the application site and, if necessary, submitters' sites. During the site visit, the commissioners will not speak to any of the parties directly about the application's merits.

The chair has directed that evidence is to be pre-circulated for this hearing. See the attached Direction. In accordance with the Direction, evidence is due to be received by the Hearings Advisor as follows.

As per the direction the following apply:

- (a) **The council** officer's report (section 42a) and any evidence will be available on the council website no later than **5pm on Friday**, **1 July 2022**.
- (b) **The applicant** is required to provide all its briefs of evidence by 12 noon on **Friday**, **8 July 2022**. You will be advised once the evidence is available.
- (c) Any submitter proposing to call expert witnesses is required to provide briefs of their evidence by 12 noon Friday, 15 July 2022. An expert is a professional such as a planner, traffic engineer or similar.

Submitter non-expert evidence and legal submissions have been requested to be provided by 12 noon on Wednesday, 20 July 2022

The submitter is required to provide:

- 1 hard copy of the evidence
- 1 soft copy briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.

Electronic copies of evidence can be sent to the Hearings Advisor at DS-Hearings@aucklandcouncil.govt.nz, Attn: Bevan Donovan

Any submitter who is providing a personal statement to read at the hearing, are encouraged to provide these electronically to the Hearings Advisor by midday, two working days prior to the hearing as well as bringing 1 copy to the hearing. This will allow for contactless exchange of evidence and enable parties, whether in attendance or participating virtually to view the material prior to the hearing. If you have not provided the statement in advance of the hearing, please bring 1 hard copies with you.

- (d) A short-written summary for briefs of evidence in excess of 10 pages is helpful. It is likely the commissioners will request that this at least is read at the hearing.
- (e) Email will be the address for service for the submitters unless advised otherwise.
- (f) If the hearing is held virtually, or you plan to attend virtually, please ensure your evidence is provided to the Hearings Advisor electronically before the hearing commences. The

panel members will have already read your original submission and they will have that in front of them at the hearing.

If you wish to attend the hearing, please fill in the attached appearance form and return it to me by Friday, 15 July 2022.

At the date of this letter Auckland is in the orange setting of the COVID-19 Protection Framework. There are restrictions with face-to-face hearings at this level that include:

- 1m social distancing required in public spaces such as the hearing room and foyer area. This is an Auckland Council requirement. This may mean there is a possible restriction on the number of people who can attend the hearing in person to ensure social distancing is adhered to. The Hearings Advisor will discuss this with the parties before the hearing to ensure these requirements are adhered to
- Use of a face-covering is mandatory at some indoor venues including premises operated by local government agencies. This includes the hearing venue
- No participants are to attend who have COVID-19 symptoms or who need to be in isolation/quarantine for any reason.

For those participants who cannot attend in person or who wish to attend virtually, please let the Hearings Advisor know by Friday, 15 July 2022 (or as soon as possible before the hearing) and they will send you a MSTeams link prior to the hearing.

Should it be determined at any time that it is not safe to hold the hearing face-to-face, the Hearings Advisor will contact you about how we will proceed with the hearing, which could be virtually via MSTeams.
