- 4. The reason for this is, in accordance with Part 2 of Schedule 1 of the RMA, any modifications to the plan change application must be made prior to the Local Authority considering the request under S25 of Schedule 1. As this private plan change has already been notified, the S42A report will be based on the private plan change as notified. The chair, in setting the hearing timetable, will take into consideration the extent of any proposed changes to ensure all parties have sufficient time to prepare for the hearing.

1. INTRODUCTION

- **1.1** This memorandum is filed on behalf of Te Whatu Ora Health New Zealand (Waitematā) (the **Applicant**).
- **1.2** The Applicant has filed an application for a Private Plan Change to amend the provisions of the Auckland Unitary Plan (Operative in part) which apply to the Mason Clinic Site located in the Wairaka Precinct, together with recently purchased sites to the north and south of the existing site (the **Application**).
- **1.3** In a Hearing Direction issued 15 February 2023, the Chairperson directed the Applicant:

...to file a memorandum outlining what, if any, changes they recommend to the proposal and outline which changes are in response to which submissions.

- **1.4** This memorandum is filed in response to that Direction.
- **1.5** This memorandum also addresses a change to the name of the entity that is the Applicant of the Application.

2. CHANGE TO THE APPLICANT

- **2.1** The Application was originally made by Waitemata District Health Board.
- 2.2 On 1 July 2022, Te Whatu Ora Health New Zealand and Te Aka Whai Ora Maori Health Authority became the new national health authorities for New Zealand. At this time, the Waitemata District Health Board (and all other District Health Boards) was disestablished and incorporated into Te Whatu Ora Health New Zealand.
- **2.3** The Applicant for Plan Change 75 is now Te Whatu Ora Health New Zealand (Waitemata).

3. PROPOSED AMENDMENTS

- **3.1** The Application was publically notified on 26 May 2022. Three submissions were filed; from Auckland Transport, the Ministry for Housing and Urban Development (**MHUD**), and Geoffrey and Joanna Beresford.
- **3.2** The Applicant has considered each of the points raised in the submissions and has had discussions with each submitter. Those discussions are ongoing with Auckland Transport and it is intended to touch base with the Beresford's in the near future.
- **3.3** At this stage the Applicant proposes to make the following amendment to the Application in response to the MHUD submission (shown as red tracking):
