#### WHAT HAPPENS AT A HEARING

At the start of the hearing, the Chairperson of the District Licensing Committee will introduce the Panel Members sitting on the hearing committee and he/she will briefly outline the procedure for the hearing. The chairperson also confirms that they and the committee members don't have any conflicts of interest and are able to consider the application impartially. The Chairperson may then call upon the parties present to introduce themselves to the committee.

The Chairperson is addressed as Mr Chairman or Madam Chair.

Any party intending to give written or spoken evidence in Māori or speak in sign language should advise the hearings advisor at least five working days before the hearing so that an interpreter can be provided.

Catering is not provided at the hearing.

#### The Hearing Procedure

The usual procedure for a District Licensing Committee Hearing is:

- The applicant will be called upon to present his/her case either personally or through a representative. The applicant may be represented by legal counsel or consultants and may call witnesses in support of the application. All witnesses will be required to take either an oath on the Bible or an affirmation. After the applicant has presented his/her case, the committee may have questions for them and their witnesses. The chairperson then invites the reporting agencies (Police, Medical Officer of Health and licensing inspector) and any objectors to ask questions. This questioning is called cross-examination. Members of the District Licensing Committee may ask questions to clarify the information presented.
- Reporting agencies (Police, Medical Officer of Health and licensing inspector) are then
  called upon to speak. They can make submissions and are then sworn in (by oath or
  affirmation) if they are going to present any evidence. The agencies must answer questions
  from the committee. The applicant and objectors may also ask them questions when it's
  their turn to cross-examine
- Objectors who wish to speak will be called next. Objectors may speak themselves or be represented by legal counsel or consultants and may call witnesses on their behalf. Each speaker will be required to take either an oath on the Bible or an affirmation. Objectors cannot introduce new grounds for objecting but can present evidence to support their reasons for objecting. The committee members or chairperson may question the objector or their witnesses. The applicant and the reporting agencies can also ask questions about the evidence
- Once objections and cross-examination has finished, the applicant or his/her representative
  has the right to summarise the application and reply to matters raised by objections.
  Members of the District Licensing Committee may ask further questions of the applicant at
  this stage.
- The chairperson then generally closes the hearing and the applicant, objectors and their representatives leave the room. Sometimes the chairperson will give a verbal decision otherwise the District Licensing Committee will then deliberate and will release its decision in writing in due course.

Should you wish to present written submissions or evidence in support of your application or objection please ensure you provide the number of copies as indicated on your notification letter previously sent to you.

At any stage during the hearing, members of the District Licensing Committee may ask questions.

#### 2. Executive summary

This is a report on a new on-licence application. The criteria found at section 105 of the Sale and Supply of Alcohol Act 2012 (the Act) apply to the application.

The application has resulted from the establishment of a new business at the premises.

43 public objections have been made. Police do not oppose the application. The Medical Officer of Health does not oppose the application. I do not oppose the application.

#### 3. External reports and public objections

#### 3.1 Police

Police reported on the application on 23 March 2021 and do not oppose the application.

#### 3.2 Medical Officer of Health

The Medical Officer of Health reported on the application on 22 February 2021 and does not oppose the application.

#### 3.3 Public notices

The application has been publicly notified as follows:

#### 3.4 Public objections

45 public objections have been made within the required timeframe. Two objections have since been withdrawn.

Some of the objectors appear to have greater interest in the application than the public generally because they live within 1km of the proposed licensed premises and work within the Karangahpe Road area. The objections relate to the criteria at section 105 of the Act. The grounds for objecting are:

- a) Suitability of the applicant section 105 (1)(b)
- b) The days and hours during which the applicant proposes to sell and supply alcohol section 105 (1)(d)
- c) The design and layout of any proposed premises section 105 (1)(e)
- d) The amenity and good order section 105 (1)(h)

#### Validity of objections

I believe that five objections do not qualify under section 102(1) of the Act. Those objections are:

- Candance Casady resides in Bellevue, Washington, United States of America.
- Kim Jones resides in Chicago, Illinois, United States of America.
- Phoebe Duke resides in Grey Lynn.
- Hannah Harmon resides in Wellington.
- Joel Hildebrandt resides in Hobson Street.

The above-mentioned objectors do not live within 1km of the proposed premises.

#### 4. The applicant

The applicant is a private company incorporated on 17 August 2020. The sole director and shareholder is Christopher Rhys Mansfield. The applicant's experience with licensed premises is detailed on the application form, and is sufficient for this type of premises in this area.

A general discussion was had with the applicant, Christopher Mansfield during an inspection. The following was discussed

#### **Experience**

Mr Mansfield has experience in managing licensed premises. Mr Mansfield currently holds a manager's certificate that expires on the 14 December 2022. The first certificate was obtained on the 2 March 2017.

#### Operation of premises

The applicant indicated that they won't be operating like a standard bar. What makes them different is that they are mainly focussing on premium wine and cocktails.

#### Food

The food menu has been amended as the original options was only platters. The amended menu is attached and dated 30 April 2021. The owner has added three substantial options that are not part of the platters.

The menu is designed to accompany the beverages so that they go hand in hand. Patrons will have the ability to select and create what they want on their platters. In the applicant's words:

"As an example, you need a spread with your starch, plus either meats or seafood with your spread, then vege with your meats or seafood. And of course, you cannot have any of the above without cheese! With multiple offerings in each 'category', it has been created to entice the customer to have course after course."

#### Staff

Mr Mansfield will have approximately 3-4 staff onsite. Staff training will be given to ensure that all staff are compliant with the Act and the licence conditions.

It is anticipated that a security will be onsite on Thursdays, Fridays, and Saturdays.

The applicant is aware of its responsibility under the Act.

The applicant doesn't seek any endorsements for the licence.

There are no concerns with the applicant's suitability.

#### 5. The premises

#### 5.1 Planning and building certificates

A planning and building certificate is attached. The proposed use of the premises meets the requirements of the Resource Management Act 1991 and the building code. The certificate has the following advice notes:

- The hours of operation of the premises are restricted to 8am to 4am the following day Monday to Sunday.
- The maximum occupancy of the premises is restricted to 18 persons inside the premises, balance of patrons to exterior and common areas.

#### 5.2 Licensed area

Most of the premises is easily visible from the point of sale. The licensed area is more precisely identified on the plan date stamped as received by Auckland Council on 14 February 2021.

The interior of the premises is designated as a supervised area with the exterior being undesignated. An outdoor dining licence is not required for the exterior area as it is within a private area.

There are no concerns with the design and layout of the premises.

#### 5.3 Inspection

I visited the premises on 31 March 2021 at approximately 2.30pm. The premises were still undergoing renovations when I visited. A full compliance visit will be made to the premises once fully operating and open to the public.

The applicant appears to have appropriate systems, staff, and training to comply with the law. There are no concerns with other goods and services provided at the premises.


#### 6. Environmental scan

#### 6.1 Introduction

The premises are located in a commercial/shopping/entertainment/ area of Auckland Central. The premises are within a 24/7 alcohol ban area. The nearest residential buildings are approximately 65m away.

#### 6.2 Density

Within 250m of the premises are approximately 48 on-licensed premises, 23 of which are licensed as taverns.



Indicators that the effects of on-licence density may have a negative effect<sup>1</sup> include the area's current levels of:

- alcohol-related harm
- deprivation
- licence density.

Karangahape Road has many issues that mainly arise in the night-time where the Police are called to attend to these matters. There is no information to suggest that other premises of this kind would be linked to alcohol-related harm. The Police have reported with no opposition.

The "NZDep2018 Index of Deprivation" shows the deprivation index as 6.

A score of 1 means the area is in the **least deprived** 10 per cent of areas in New Zealand. A score of 10 means the area is in the **most deprived** 10 per cent of areas in New Zealand.



The deprivation index combines 2018 census data relating to income, home ownership, employment, qualifications, family structure, housing, access to transport and communications to give a measure of the socioeconomic deprivation of the area.

Socio-economic deprivation increases the likelihood of experiencing alcohol-related harm, at least in part due to consumption patterns and rates of alcohol-use disorders. Moreover, emerging evidence suggests alcohol-related harm may actually drive social and economic inequalities.<sup>2</sup>

In my view, there is no reason to suggest that the area's current levels of alcoholrelated harm, deprivation and density are at a level that a new on-licence would likely make the area worse.

It is important to mention that it is up to the applicant to ensure that they manage the premises properly and ensure that they do not contribute to alcohol-related harm and the issues of noise, nuisance, and vandalism.

Given that a licence is only issued for one year, it is the applicants licence to lose.

#### 6.3 Sensitive sites

Within 250m of the premises are four places of worship, three schools and two early childcare centres.

#### 6.4 Noise, nuisance and vandalism

During visits to the locality generally, I haven't observed any issues of noise, nuisance or vandalism. There is nothing to suggest that licensing these premises will cause noise, nuisance or vandalism in the area.

#### 6.5 Visual amenity

The premises are well kept.

#### 6.6 Licensed days and hours sought

The licensed days and hours applied for are:

Monday to Sunday 8.00am to 3.00am the following day

The licensed days and hours sought are listed at the conditions section of this report. This seems appropriate given the nature of the proposed licensed premises and the nature of the locality.

#### 6.7 Comment

There is no reason to believe that the amenity and good order of the locality would be likely to be reduced, to more than a minor extent, by the effects of the issue of the licence.

Also, there is no reason to believe that the amenity and good order of the locality is so bad from other nearby licences that, although granting this licence will have little negative impact, it is nevertheless desirable not to issue this licence.

#### 7. Conclusion

#### 7.1 Conclusion

Standing back and considering the application, there is nothing to suggest that granting this application would not achieve the object of the Act, which is ensuring the safe sale, supply and consumption of alcohol, and minimising alcohol-related harm.

#### 7.2 Conditions

The applicant has agreed in writing (attached) that the following conditions best suit the way they intend to operate the premises:

- (a) No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold only while the premises are being operated as a tavern, and only during the following days and hours:
   Monday to Sunday 8.00am to 3.00am the following day

- (c) Drinking water must be available to customers from a self-service station, service to tables or upon request.
- (d) The host responsibility policy that was submitted with the application must be complied with.
- (e) No intoxicated persons may be allowed to enter or to remain on the premises.
- (f) Appropriate signage regarding the restrictions on the supply of alcohol to minors and intoxicated persons must be prominently displayed adjacent to every point of sale.
- (g) The whole interior of the premises is designated as a supervised area. The exterior is undesignated.

#### 2. Executive summary

On 27 April 2021 the District Licensing Committee (DLC) issued a memorandum in relation to disclosing the contact details and identities of objectors that had requested for their information to not be disclosed to the applicant.

At paragraph 6 of the memo, the DLC said:

[6] The Committee has no ability to suppress the names and descriptions of parties to the application. Objectors claiming status pursuant to s. 102(1) of the Act are parties to the matter. I note that the Inspector is still to determine if the Objectors have status. On the information before me, namely the seven (7) notices of objection, then it is likely that some of those will not meet the criteria as having a greater interest in the application for the licence than the public generally. Those of course are decisions for the Committee to determine should the matter come before it at any hearing.

From the seven objections that had requested for their contact details or identities to not be disclosed, four have withdrawn.







#### HOST RESPONSIBILITY POLICY

- All staff will be trained how to recognise the signs of intoxication
- Any person displaying two or more signs that their Speech, Coordination,
   Appearance or Behaviour is affected will not be served any further alcohol and the duty manager will be called to assess that person.
- Any intoxicated person found on the premises will be taken to a place of safety on the premises or if safe to do so will be removed from the premises.
- Alternative drinks and food will be recommended by staff when a person shows signs
  of being influenced by alcohol.
- Regular checks will be made of the toilets to prevent and detect persons taking drugs or becoming intoxicated.

#### **FOOD**

- Signage will be displayed advising the range of food available
- We will always have available for customers at least 3 different substantial types of food.
- The food available will be as set out in the Menu attached to our application.
- The food available will be promoted throughout the premises and staff will actively
  encourage the consumption of food to slow the onset of intoxication.
- We will always have meals available, of a similar style and range as set out in the menu attached to our application, whenever alcohol is being sold or consumed.

#### NON-ALCOHOL AND LOW-ALCOHOL BEVERAGES & WATER

- We will stock a range of non-alcoholic and low alcohol beverages.
- We will ensure that our staff are aware of the options available.
- Tap water will be provided free of charge either at the bar/table or prominent location to all patrons.

#### SAFE TRANSPORT OPTIONS

- We will ensure that information on public transport options is available.
- A telephone is available should customers wish to call a taxi.
- We will ensure that our staff are instructed to give advice to customers on the transport options available.

#### SAFE DRINKING ENVIRONMENT

- We will ensure that empty glasses and bottles are cleared promptly.
- Violent, quarrelsome, insulting, or disorderly customers will not be tolerated on the premises and will be removed regardless of whether they are intoxicated or not.
- We will regularly check to ensure that the toilet facilities are kept clean safe and available.

#### **AMENITY & GOOD ORDER**

- Staff will be instructed to be mindful of the need to manage noise so as to not disturb our neighbours.
- Doors and windows will as much as possible be kept shut to reduce the flow of noise from the premises.

- No photo copies of evidence of age documents accepted
- Anyone suspected of purchasing liquor for consumption by a minor will be refused service.

#### **Intoxicated Persons**

No intoxicated persons will be sold alcohol.

Price discounting/Promotions that encourage excessive consumption

• The licensee will not be heavily discounting alcohol prices and there will be no promotions that may increase the likelihood of excessive consumption or "risky drinking"

#### Premises

- The premises will be kept in a clean and tidy manner.
- Rubbish will be removed on a regular basis
- Any graffiti or similar will be removed
- Cartons and packaging from the premise will be located out of view from the general public.
- At night the premise exterior will be well illuminated

#### **Deliveries**

• To be made during the "working day" to reduce noise.



I hereby object to the application for a liquor license by the mentioned 'Chris Mansfield' on the grounds of his unsuitability as an applicant for tavern located, St Kevins Arcade set to be named "Tomfoolery" through company - Front. Left LTD.

I strongly suggest this application for a liquor license from this particular person is denied. I currently have a permanent personal protection order against this individual, due to his volatile and aggressive nature, I've experienced first-hand with him. His irrational and illogical behavior, severally impairs his decision-making process which in turn many innocent people have suffered from.

Personally, experiencing this individual's violent and aggressive nature is exacerbated by alcohol, this would be hugely irresponsible and unsafe for the council to allow a liquor license to go ahead.

I have another concern with the proximity of this establishment being so close to my residential address - 1.2 KMs away. Again, with a permanent protection order against this individual, I have huge concerns for my safety and mental wellbeing allowing my violent offender to open an alcohol establishment within my very neighborhood. I'm pregnant and due to have a child, and I fear I wouldn't be able to walk or stroll my usual routes without risk of contact. This is causing me huge amounts of undue stress already.

Chris Mansfield is 100% an unsuitable applicant for a liquor license, on the grounds of <u>public safety</u>. Apart from my personal experience with him, he has previous history of violence and aggression towards many women and men, including domestic violence / assault charges.

I have personally heard from victims who have felt mentally triggered and now very concerned for the general public safety, with the possibility of this person being granted permission to run any public establishment, particularly involving the sale of liquor.

From a professional / business perspective due to Chris Mansfield's distortion of truth and personal integrity, I have grave concerns about his business practices, including the safety of his staff, particularly his treatment towards women, with his track record of aggression and violence, and the honesty of his financial practices.

Once again, I strongly object to the application of alcohol licensing on the grounds that Chris Mansfield is an unsuitable applicant. It would be in the interest of public safety that this is denied.

This attempt is in hopes of providing critical information to your board as you consider both his application, and also the safety and protection of the Auckland public.

While living in Seattle, Christopher Mansfield had a reputation of the following:

- Frequent cocaine and illegal drug use in restaurant and pub bathrooms
- Excessive abuse of alcohol; "Blacking out" every drinking weekend
- Bar fights with patrons, bartenders, and bouncers
- Physical abuse of his girlfriends in restaurants and bars; behavior escalated while drinking
- Sexual and violent harassment, and threats towards fellow patrons, women, and men

#### To Whom It May Concern:

I am writing to you as a concerned citizen with respect to the pending license application of Chris Mansfield for his proposed bar concept, which I understand is aptly named "Tomfoolery."

Mr. Mansfield suffers from untreated mental illness and has a long history of domestic violence. Everywhere he goes, he leaves behind him a trail of victims, including in Seattle, Washington (where he still has a warrant out for his arrest), New Zealand and Australia. I am currently a resident of Chicago in the United States. I had to move here from Seattle telling Mr. Mansfield I was "going on vacation" since I was quite sure he might kill me if he knew I was leaving for good. I have this in common with many of his victims with whom I am personally acquainted as we have formed something of an online support group. In 2019, when the other victims and I found out about Mr. Mansfield's involvement in the dating show "Married at First Sight," we made contact with the production network and let them know about his background, out of concern for his prospective wife. It turned out they had ALREADY kicked him off of the show before its release, because he had been violent with other show members. Mr. Mansfield is capable of presenting as very charming -- but he is also capable of deadly violence and is not able to control his fits of rage, especially towards women. He needs professional intervention.

We, the women he has previously targeted with violence and abuse, are desperately scared for the unsuspecting women Chris may be able to further victimize through his proposed bar. We are not acting on a vendetta, but rather a deep concern that this establishment will continually feed more victims to Mr. Mansfield. I ask you to imagine whether you would be comfortable with your own daughters frequenting a bar run by a man with his background.

While it is difficult to face the stigma of speaking out in this nature, I hope you will take this letter and its plea under consideration, and that you will deny Mr. Mansfield's license application. Your community will thank you for it.

Chris Mansfield has been reported to have outstanding domestic violence charges in the United States.

In a media article in Stuff,¹ journalist Glenn McConnell states that: "Mansfield was edited out of the [Married at First Sight NZ] reality programme during its final season, in 2019, after it was revealed he had an <u>outstanding domestic violence charge</u> against him in the United States. Production sources told *Stuff* there had also been issues with Mansfield during filming and that he was "<u>aggressive and volatile</u>". "In 2009, <u>he was arrested</u> in the US and pled not guilty on an assault charge. Court documents showed he was due back in court on June 15, 2009, after pleading in May, but did not appear. A warrant was issued for his arrest on charges of failure to appear on the domestic violence charge."

Chris Manfield is unsuitable to hold an alcohol license. This is an individual that has not abided by the laws of a country and has an outstanding warrant. Furthermore, the charges that he has been alleged with, and not proven to be innocent of is violence related.

Minimising the harm caused by the excessive or inappropriate consumption of alcohol is an important part of the act, and particularly important to the area of Karangahape Road where there is already heightened antisocial behavior that is linked to excessive alcohol consumption.

I don't believe this applicant is able to direct and manage the sale and consumption of alcohol in a safe and responsible manner, and would not minimise harm caused by inappropriate alcohol consumption.

I'm writing to formally object to the liquor license application currently underway by Chris Mansfield for a new premises in St Kevin's Arcade to be called 'Tomfoolery'. I object to this application based on the suitability of the applicant.

It is a matter of public record that Mr. Mansfield has an outstanding domestic violence charge in the United States. Not only was a charge brought against him as a result of a criminal complaint, but he has intentionally evaded answering that charge in a court of law. Furthermore, he was subsequently arrested in the United Statesfor driving with a suspended license. I do not believe that a person who breaks the law is of suitable character to hold a liquor license; more importantly, I do not believe that a person who avoids accountability for their actions - criminal or not - is of suitable character to hold a liquor license.

I often have reason to visit the Karangahape Road area, and have some involvement with the marginalised community who frequent the area through Lifewise, Auckland Street Choir, Merge Cafe and other connections. I'm very concerned to see that Chris Mansfield has lodged an application for yet another bar on K Rd, as this will put more stress on an already somewhat fragile community.

Here are my reasons for objecting.

K Rd already has more than enough alcohol venues, and I know that some of the local residents already have significant trouble because of late-night drinking culture (people throwing up - and worse - in their apartment doorways etc.

The applicant has a documented history of aggressive, volatile behaviour, and has fled a domestic violence charge in the US. Late night bars are notoriously volatile environments and someone with this instability would not be a suitable governor of tense situations. I don't know the applicant personally so can only go on the documented evidence.

I have never before objected to an application for a liquor license. I live in Westmere, but I am regularly on K Road and nearby for my work and community projects I am involved with (Lifewise and the Auckland Street Choir). I'm not against alcohol at all, but the impact of this licence being approved would be disproportionate.

This is an exceptional case, involving a person who feels entitled to flout the law and engage in abusive behaviour without consequences. I respectfully request that you deny Chris Mansfield a license to sell alcohol.

I am objecting the granting of a Liquor License to <u>on the grounds of Suitability of the Applicant</u> under the Sale & Supply of Alcohol Act (2012). More accurately, due the unsuitability of the applicant and sole director of Front. Left Ltd, Christopher Mansfield.

As has been publicly reported, Mr Mansfield has been subject to a domestic violence charge. Rather than plead his case, he failed to appear in court on this charge. A warrant was then issued for his arrest, in the US – he returned to NZ instead. Failure to appear in court and respect legal process on such a serious issue raises huge concerns about his suitability.

Then, in 2019, Mr Mansfield was removed by producers from an NZ reality TV show he had been cast in. All contestants are obliged to declare any charges or convictions, or anything that could bring the show into disrepute; Mr Mansfield was dishonest – he failed to declare the charges. He was also described as "aggressive and volatile". This is not hearsay; this was comment made by representatives of a major media organisation following his departure. I am a long-time producer of television shows; I know that difficult, not-always-likeable "characters" make for great TV. You want to *keep* those people, because "drama" is good for ratings in reality competition shows. So, for someone to be made to leave a show in this way means the concerns of producers about Mr Mansfield's character were serious.

The proposed venue is in St Kevin's Arcade on Karangahape Rd. I am a long-time K Rd resident and love my community. I have also seen the difference between well-run premises and those that are not. It's a challenging time in our neighbourhood; post Covid there are a greater number of people sleeping rough, and a noticeable uptick in violence, drug dealing and mental health crises. How does this relate? The hospitality sector crosses paths with other retail businesses, with residents, with visitors — and with the street community. The last thing any of us want or need is a venue proprietor who not only thinks it's ok to skip out on domestic violence charges, but whose temperament — in an unpredictable business in a very unpredictable neighbourhood — is noted as aggressive and volatile.

I do not believe the applicant meets the object of the Act, as Mr Mansfield is the sole director and shareholder of the applicant company and I do not believe the supply of alcohol can be undertaken responsibly by someone who has shown himself to not respect the law, nor to be honest in his dealings with others.

I wish to object to Tomfoolery Drinkery & Pantry – Front. Left Ltd being issued an On-Licence, for the intended address of 6&7/183 Karangahape Road, Newton, Auckland.

Firstly, I am a person with a 'greater interest' than the general public as I am a resident of a local business. Secondly, that my objection to Tomfoolery Drinkery & Pantry – Front. Left Ltd is primarily based on the suitability of the applicant behind the company, Chris Mansfield.

According to reporter Brookes from *Stuff Ltd*,<sup>1</sup> and reporter Leask from *The New Zealand Herald*,<sup>2</sup> prior to filming season three of *Married at First Sight NZ*,<sup>3</sup> participants were required by *MediaWorks* to confirm they had no undisclosed convictions as part of routine criminal record checks. In not disclosing his outstanding domestic violence charge prior to participating in the show, both the incrimination and failure to acknowledge this contractually, make Mansfield unsuitable as an applicant for an On-Licence. Domestic violence behaviour is never an isolated incident<sup>4</sup> and reflects extremely poorly on the character of Mansfield as coercive and exploitative of his power, per inference of domestic violence.<sup>5</sup> Laterally applying this knowledge of domestic violence from an intimate setting to a work one, it is possible to extrapolate his behaviour patterns. An applicant with history of abusive control should not be allowed in a setting as volatile as hospitality. This is endorsed knowing he will be overseeing employee relationships and inebriated patrons.

Furthermore, it is my impression that slogan for the tavern, 'For those that like their drinks proper, and their yarns the opposite', supports male hegemony. This is defined as an "internalisation of cultural belief systems and attitudes toward masculinity" (p.131). A known pattern of traditional masculinity is 'to given 'em hell' – the endorsement of adventure even if violence is necessary.

believe there is an alignment between this custom and the use of the term '...drinks proper, and their yarns the opposite' as the tavern's slogan. This link is in defining adventure as an unusual or daring experience, positioning the term alongside 'the opposite of proper'. Therefore, the affiliation of adventure (supporting the possibility of violence) with taking charge, there is a known link to sexual aggression. The motto of Tomfoolery Drinkery & Pantry – Front. Left Ltd endorses a culture of male hegemony and sexual aggression. An implication of which is an unsafe space for women and the rainbow community, the latter who make Karangahape Road and its culture as valuable and historic as it is. This therefore reinforces the unsuitability of an applicant who actively participates in such a culture.

Both Mansfield's demonstrated character and the analysis of his slogan, indicate a venue which provides little reassurance of customer and community wellbeing.

Next, a few brief statements on the direct alcohol-related-harm Tomfoolery Drinkery & Pantry — Front. Left Ltd will contribute to. Statistical history demonstrates the correlation of greater density of liquor outlets to alcohol-related-harm. Paul Reid's purchase of St Kevins Arcade in 2015 saw the number of licenced establishments more than double. In addition, we know that Māori peoples — a long standing Karangahape Road population, are reported to be 1.8 times as likely to face hazardous drinking patterns compared to non-Māori. Delieve that additionally, the opening hours for this venue are unsuitable as 8am to 3am for licence hours makes readily available greater chance of hazardous and harm-related behaviours. Looking at the Sale and Supply of Alcohol Act 2012, an aim is to minimise the harm from inappropriate drinking, including crime, disorder, public nuisance and negative public health outcomes (p.4). The summation of this paragraph is that harm from inappropriate drinking would increase with the granting of an On-Licence for this premises.

Referring to the design of the premises, notably the lack of bathrooms. The *Guidelines for Crime*Prevention through Environmental Design for Licensed Premises<sup>12</sup> notes that "toilet facility entrances should be clearly visible from the bar" (p.17). This is not the case for the proposed On-Licence premises and would contribute to the strain of minimal existing bathrooms in St. Kevins Arcade.

Public nuisance as aforementioned, has the potential to increase in this scenario as there are many

surrounding venues providing food and drink with extremely limited bathroom options. Locals are worried that Myer's Park, which St Kevins Arcade backs onto, will become a substitute toilet unavailability.

It is to my best knowledge that this objection is factually true.

I'm writing to object to the issue of a liquor license to Tomfoolery Drinkery & Pantry - Front. Left Ltd, 7/183 Karangahape Rd, Newton (advertised 15/2/2021 online).

As a nearby local resident for over 13 year and local school teacher, I feel uniquely position to comment on this particular application.

There are three main areas of objection:

- 1) Hours of operation. There is a distinctive disconnect between an 8am-3am liquor license and the surrounding amenities. The arcade is a through fair to a children's playground, and includes on the school route and commute for many central dwelling students. It does not send the correct message to families attending the nearby kindergarten or after school students who regularly and routinely use this area.
- 2) Yet another bar/alcohol focussed establishment in the area. The rapid gentrification of K Rd has meant that many new alcohol serving businesses have popped up over the last 5 years. In that time crime, public urination/defecation, harassment, public drinking and littering has exploded. Until there is a regular patrol and council cleaning for this sort of imported pollution, there should not be another venue (for the sole purpose of drinking) be opened.
- 3) Existing culture. The establishment of a loud public bar right in the entrance of the arcade does not compliment the exhausting ecosystem of the arcade. There is already considerable noise from the recent opening of at least 5 new eateries in recent years. Another loud bar is not going to enhance the existing spectrum of uses the arcade currently fills.

I am writing to submit my objections to the proposed alcohol license for this establishment.

My objections are based on several relevant factors:

- The owner Chris Mansfield has a history of violence and domestic abuse

# **Acknowledgement of Agreed Conditions**

I, Christopher Mansfield, on behalf of Front.Left Limited, have discussed with Alcohol Licensing Inspector Nathan Tanevesi, the way we intend to operate the premises if granted a Licence. We intend to operate in the style of a tavern and we agree that the following conditions are suited to how we intend to operate the Licence. We have not agreed to any other conditions.

# **Agreed Conditions:**

- (a) No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold only while the premises are being operated as a tavern, and only during the following days and hours:

#### Interior and Exterior

Monday to Sunday 8.00am to 3.00am the following day

- (c) Drinking water must be available to customers from a self-service station, service to tables or upon request.
- (d) The host responsibility policy that was submitted with the application must be complied with.
- (e) No intoxicated persons may be allowed to enter or to remain on the premises.
- (f) Appropriate signage regarding the restrictions on the supply of alcohol to minors and intoxicated persons must be prominently displayed adjacent to every point of sale.
- (g) The whole interior of the premises is designated as a supervised area. The exterior is undesignated.
