RESOURCE CONSENT APPLICATION – NOTICE OF HEARING

Applicant	Kainga Ora
Proposed activity	Resource consent for the subdivision of approximately 3.87ha of land in Avondale to create nine vacant residential superlots (which will allow for the future development of 229 new dwellings), 8,191m2 of new roading to vest and a 1,478m ² park to vest. The proposal includes bulk earthworks to clear the sites of the existing buildings and vegetation; contamination remediation; the removal of two existing street trees; planting of 54 new street trees.

You are invited to attend the hearing where the Hearing Commissioners will consider submissions in support of/or opposing the application. Attendance via Skype is available on request, by contacting the hearings advisor by Wednesday 30 June 2021 by 12 noon.

Please note the commissioners will carry out a site visit, individually or together, either before, during or after the hearing which may involve them going on to the application site and, if necessary, submitters' sites. During the site visit, the commissioners will not speak to any of the parties directly about the application's merits.

Pursuant to section 103B of the Resource Management Act 1991 (RMA), the pre-provision of evidence is <u>mandatory</u>. The council and the applicant are required to provide all evidence prior to the hearing. The submitters are required to provide any expert evidence before the hearing but can provide non-expert evidence (i.e. personal submissions) at the hearing. Due to the hearing date moving, more time has been provided to the parties to provide evidence than what the RMA specifies.

The following apply:

- (b) **The applicant** is required to provide all its briefs of evidence no later than Wednesday 16 June 2021. You will be advised once the evidence is available.
- (c) **Any submitter** proposing to call expert witnesses is required to provide briefs of evidence from those experts prior to the hearing. An expert is a professional such as a planner, traffic engineer or similar.

To ensure this evidence is available on council's website for other parties, it is required by midday, Wednesday 30 June 2021. It must be sent to the applicant at the same time. The applicant's contact email address is <u>sarahr@barker.co.nz</u>

The expert witness is required to provide:

• 10 hard copies of the evidence

 1 soft copy - briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.

We encourage any submitter who is providing a personal statement to read at the hearing, to provide this electronically to the Hearings Advisor by midday, Wednesday 21 July 2021. The requirement to bring 10 hard copies of these statements to the hearing remains.

- (d) A short-written summary for briefs of evidence in excess of 10 pages is helpful. It is likely the commissioners will request that this at least is read at the hearing.
- (e) The council will make available all reports and evidence on its website within 24 hours of receipt or as soon as is practicable. The link to the website is:
