### **Notice of Requirement for designation for the Whenuapai Wastewater Servicing Scheme Package 1**

#### **Notice of Requirement**

Auckland Council has received a notice of a requirement for a designation from Watercare Services Limited as the Requiring Authority, for the Whenuapai Wastewater Servicing Scheme – Package 1 Project.

The requirement is for the construction, operation and maintenance of the proposed Whenuapai Wastewater Servicing Scheme – Package 1 Project, which includes a gravity main, pump station, rising main, and associated infrastructure.

The site to which the requirement is located at:

- Round Crescent, Whenuapai
- Tamiro Road, Whenuapai
- 20 – 22, 26, 23A, 23 – 27, 28 and 31 Brigham Creek Road, Whenuapai
- 8, 15 – 19 Spedding Road, Whenuapai
- 32 Mamari Road, Whenuapai

#### **Making a submission on the notice of requirement**

Any person or organisation may make a submission on the notice of requirement, but a person who is a trade competitor of the requiring authority may do so only if that person is directly affected by an effect of the activity to which the requirement relates that –

- (a) Adversely affects the environment; and
- (b) Does not relate to trade competition or the effects of trade competition.
