Thank you for your time on the phone yesterday. As discussed, in order to set up the contract in our system we require a proposal from you that outlines the work to be delivered and the fee. Below is a high-level summary of the background and status of this project. Please note that this information is commercially sensitive and should not be circulated.

- 1. The Ormiston Flat Bush area is located in the Ormiston Mission Heights catchment as defined in the National Education Growth Plan (NEGP), which has been identified as an area of significant current and future growth. There is significant greenfield growth, with intensive development ongoing. Collectively, once all developments are complete, there are expected to be 5,550 additional dwellings in the Ormiston Mission Heights catchment.
- 2. A new full primary is proposed to cater to years 1-6, with a build roll of 600 students and a

master-plan roll of 1,250 students. The proposed opening date for the school is 2023 (this is unlikely to be achieved but has been brought forward due to the faster than anticipated growth).
