

## Auckland Unitary Plan

### Notification of Material to be Incorporated by Reference into the Auckland Unitary Plan Operative in Part

Auckland Council is seeking to incorporate the:

- Stormwater Management Devices in the Auckland Region, December 2017, Guideline Document 2017/001 Version 1 (GD01); and
- Erosion and Sediment Control Guide for Land Disturbing Activities in the Auckland Region, June 2016, Guideline document 2016/005, Incorporating Amendment 1 (GD05)

by reference into the Auckland Unitary Plan Operative in Part under Clause 34(2)(d) of Part 3 of the First Schedule of the Resource Management Act 1991(RMA).

Material incorporated by reference is publications that have been referred to in the body of a proposed plan or a proposed plan change. This document may include standards, requirements, recommended practices or any other written material dealing with technical matters.
