# Notices of Requirement by the Minister for Children to Alter Existing Designations 3800 and 3802 in the Auckland Unitary Plan

## Sections 168, 169 and 181 of the Resource Management Act 1991

## Notices of Requirement

The Auckland Council has received two Notices of Requirement from the Minister for Children (**Minister**), as requiring authority, seeking alterations to designations in the Auckland Unitary Plan for two existing residences operated by Oranga Tamariki - Ministry for Children in Auckland.

The Notices of Requirement seek to alter the following existing designations:

- Designation 3800 'Care and Protection Centre Upper North' (currently known as Whakatakapokai) at 398 Weymouth Road, Section 2 SO362124, Weymouth; and
- Designation 3802 'Youth Justice Centre Upper North' (Korowai Manaaki) at 21-24 Kiwi Tamaki Road, Lot 2 DP448846.

The Notices of Requirement relate to different residences in different locations, however the Minister is presently proposing that they be processed and considered together. Auckland Council is accordingly jointly notifying the Notices of Requirement for submissions.

### **Details of the Notices of Requirement**

The Oranga Tamariki Act 1989 has been amended and those changes are due to come into force on 1 July 2019. In order to prepare for these changes, the Minister is proposing alterations to the designations for both residences (currently known as Whakatakapokai and Korowai Manaaki) to better enable the purpose of the designations to align with these changes.

### (a) Proposed alterations to Designation 3800 (currently known as Whakatakapokai)

The main alterations proposed to this designation will allow:

- The residence to accommodate tamariki/children and rangatahi/young people for either care and protection or youth justice reasons, including those who are placed in the custody of the chief executive of Oranga Tamariki for certain adult jurisdiction reasons, or who are transitioning out of care/custody. The changes will enable the residence to accommodate rangatahi who are aged up to and including 19 years old (although most will be under 18).
- An increase in the number of tamariki and rangatahi who may live at the residence (from 20 to 30).

### (b) Proposed alterations to Designation 3802 (Korowai Manaaki)

The main alterations proposed to this designation will allow:

- Korowai Manaaki to accommodate tamariki and rangatahi who are placed in the custody of the chief executive of Oranga Tamariki for youth justice reasons, and certain adult jurisdiction reasons. The changes will enable the residence to accommodate rangatahi who are aged up to and including 19 years old (although most will be under 18).
- An increase in the number of tamariki and rangatahi who may live at the residence (from 46 to 56).

### Making a submission

Any person may make a submission on one or both of the Notices of Requirement.

Submissions close on 29 March 2019.

#### Possible 'direct referral' to the Environment Court

The Minister has requested that the Council allow the Notices of Requirement to be 'directly referred' to the Environment Court. The direct referral process is a streamlined procedure under the Resource Management Act 1991, which allows a requiring authority to make a request to the Council that its notified Notice of Requirement be decided by the Environment Court, rather than the Council.

The Council is considering the Minister's request for direct referral, and a decision is likely to be made shortly. In the meantime, the Environment Court has made various orders in relation to the proposed direct referral of the Notice of Requirement (should the Council agree to the process being used). The Court's orders simplify aspects of the direct referral process. The Court has also tentatively approved a draft timetable through to a potential hearing in the week of 20 May 2019. The Court's orders (and the draft timetable) may be viewed at the internet link provided above.
