Approval from KiwiRail Holdings Ltd under Section 177(1)(a) of the Resource Management Act 1991 (the Act) for works over a Railway Designation for a Southbound Drury Access Ramp

The railway corridor at Drury is designated in the Auckland Unitary Plan, Operative in Part, for railway purposes as 6302, North Island Main Trunk Line (NIMT). Approximately 300m to the north of the location is KiwiRail Designation 6308 Drury Station.

KiwiRail Holdings Limited (KiwiRail) has reviewed the proposal by Waka Kotahi for a new southbound access off-ramp at Drury Interchange. The ramp is an extension of SH1 and will be bridged across Great South Road, Karaka Reserve and the North Island Main Truck line (NIMT), before landing south of Flanagan Road, in the vicinity of number 130. The proposed ramp crosses over the NIMT at 641.780km.

No physical works are proposed on the track. The design maximises off-site fabrication and precast elements to reduce on-site activities. No piers will be located within the NIMT.

KiwiRail's approval to Waka Kotahi under s177 of the Act is based on the following:
