Notice of Requirement for designation New Rapid Transit Corridor, including a walking and cycling path (NoR 1)

Notice of Requirement - New Rapid Transit Corridor, including a walking and cycling path (NoR 1)

Auckland Council has received a notice of a requirement for a designation from Waka Kotahi NZ Transport Agency as the Requiring Authority, for public work.

The requirement is to construct, operate, maintain and improve a new Rapid Transit Corridor (RTC), cycleway and/or shared path and associated activities between Albany (just south of Ōteha Valley Road) and Milldale, via Dairy Flat, the proposed work includes:

- A new 16km long RTC corridor with separated walking and cycling facilities along some of its length from Bawden Road to the point where the RTC crosses Dairy Flat Highway, with connections to other proposed/existing active mode facilities.
- Works on existing State Highway 1 to construct part of the new RTC corridor.
- Batter slopes and associated cut and fill earthworks.
- New or upgraded intersections, bridges, embankments, retaining, culverts, stormwater management systems, lighting, landscaping, utility services.
- Changes to local roads, where the proposed work intersects with local roads.
- Construction related activities including vegetation removal, construction compounds, laydown areas, bridge works areas, construction traffic management and the re-grade of driveways.

The site to which the requirement applies to an area of land of approximately 191.17 hectares located between Albany (just south of Ōteha Valley Road) Dairy Flat and Milldale. The requirement applies to 241 land parcels (including local roads) (refer to Attachments A and B of Form 18).

Making a submission on the notice of requirement

Any person or organisation may make a submission on the notice of requirement, but a person who is a trade competitor of the requiring authority may do so only if that person is directly affected by an effect of the activity to which the requirement relates that –

- (a) Adversely affects the environment; and
- (b) Does not relate to trade competition or the effects of trade competition.
