Notice of Requirement for a new designation Upgrade to Dairy Flat Highway between Dairy Flat and Albany (NoR 9)

Notice of Requirement - Upgrade to Dairy Flat Highway between Dairy Flat and Albany (NoR 9)

Auckland Council has received a notice of a requirement for a designation from Auckland Transport as the Requiring Authority, for public work.

The requirement is for the construction, operation and maintenance of an upgrade to Dairy Flat Highway with active mode facilities and safety improvements between Durey Road, Dairy Flat and Albany village.

In summary the proposed works includes:

- a) The upgrade of Dairy Flat Highway with active mode facilities and safety improvements between Dairy Flat and Albany
- b) Tie-ins with existing roads and localised widening around the existing intersections to accommodate new intersection forms.
- c) New or upgraded stormwater management systems, bridges and culverts (where applicable).
- d) Batter slopes, and associated cut and fill earthworks.
- e) Vegetation removal.
- f) Other construction related activities required outside the permanent corridor including the regrade of driveways, construction traffic manoeuvring and construction laydown areas.

The requirement applies to an area of land of approximately 289,390 square metres located in Dairy Flat, Albany Heights and Albany. The requirement applies to 89 land parcels (not including legal roads). (refer to attachments A and B of the Form 18).

Making a submission on the notice of requirement

Any person or organisation may make a submission on the notice of requirement, but a person who is a trade competitor of the requiring authority may do so only if that person is directly affected by an effect of the activity to which the requirement relates that -

- (a) Adversely affects the environment; and
- (b) Does not relate to trade competition or the effects of trade competition.
