

## **Auckland Unitary Plan (Operative in Part)**

### **Proposed Plan Change 78 to the Auckland Unitary Plan (Operative in part) - Errata to the Summary of Decisions Request Report and Extension of time to Further Submission period**

Auckland Council has prepared the Summary of Decisions Requested on submissions on Proposed Plan Change 78 and notified on Monday 5 December 2022 as available and further submissions, in the prescribed form, can now be lodged as provided for in Clauses 7, 8 and 95(2) of Schedule 1 to the Resource Management Act 1991 (RMA).

An errata to the Summary of the Decisions Requested Report is available on the council website [www.aucklandcouncil.govt.nz/planchanges](http://www.aucklandcouncil.govt.nz/planchanges). The errata lists corrections, including, but not limited to, inaccuracies or missing submission points. The Summary of Decisions Requested Report should be read in conjunction with the errata. The closing date for further submissions has been extended and all further submissions must be made by **midnight 20 January 2023**.

The following persons may make a further submission, in the prescribed form:

- any person representing a relevant aspect of the public interest; and
- any person that has an interest in the plan greater than the interest that the general public has; and
- the local authority itself (Auckland Council)

A further submission may only express support or opposition to a matter raised in an original submission (made under clause 6 of Schedule 1 of the RMA). It must not raise new points of submission.

Further submissions must be lodged using the prescribed form (Form 6 of Schedule 1 of the Resource Management (Forms, Fees, and Procedure) Regulations 2003), which can be completed online or downloaded from the Auckland Council website at [www.aucklandcouncil.govt.nz/planchanges](http://www.aucklandcouncil.govt.nz/planchanges). If you don't have access to a computer, please visit your local library or service centre and staff will help you print a copy of Form 6 from the Council website.

Any hardcopy forms must be posted to: Auckland Council, Private Bag 92300, Auckland 1142, with a copy also required to be sent to the original submitter not later than 5 working days after lodging the 'further submission' with the Auckland Council (Clause 8A, Schedule 1).

The closing date for further submissions to be lodged with Council is now the **20 January 2023**.

Following the close of further submissions, the Council will prepare a summary of the further submissions, and the Council will submit all documents including submissions and further submissions to the Independent Hearings Panel under clause 97 of Schedule 1 of the RMA.
