Auckland Unitary Plan

Proposed plan change Plan Change 83 (PC83) - Additions and amendments to Schedule 10 Notable Trees Schedule) to the Auckland Unitary Plan (Operative in part)

Auckland Council has **withdrawn in part** the following proposed plan change to the Auckland Unitary Plan (Operative in Part) under Schedule 1 (clause 8D) to the Resource Management Act 1991 (RMA). The decision was made under Auckland Council Combined Chief Executives Delegation Register May 2022.

The reasons for this partial withdrawal are:

- 1. PC 83 was publicly notified on 18 August 2022. Since that time, a number of errors/irregularities have been identified which affect the accuracy of Schedule 10 and also the ability for directly-affected persons to respond to the Plan Change.
- 2. The proposed additions, deletions and amendments are to be withdrawn because there was an error in the notification under clause 5, Schedule 1 of the RMA (a directly affected person was not notified). In some cases, there was also an error in the text and/or maps that were included in PC 83 as publicly notified on 18 August 2022.
- 3. The following amendments to Schedule 10 Notable Trees Schedule are to be withdrawn from PC 83:

Proposed amendment: Delete *Cedrus deodara* from botanical name and delete atlas cedar from common name. To reflect this change total number of trees from 6 to 5.

Notification error: directly affected persons were not notified

9. ID 646- 525 Mt Wellington Highway, Mount Wellington

No changes were proposed.

10. ID 649- 658 Mt Wellington Highway, Mount Wellington

Proposed amendment: Delete Vitex lucens from botanical name.

Notification error- directly affected persons were not notified.

11. ID 650- 662 Mt Wellington Highway, Mt Wellington

Proposed amendment: Add *Vitex lucens*.

Notification error- directly affected persons were not notified.

12. ID 179- 704 New North Road, Mt Albert

Proposed amendment: Change address from New North Road 704 to New North Road 704A & amend legal description.

• Notification error- directly affected persons were not notified.

13. ID 771- 12 Pukenui Road, Epsom

Proposed amendment: Change address from Pukenui Road 12 to Pukenui Road 12A.

- Text error Investigation has found that the 1x Rimu tree is actually located at 12 Pukenui Road and not 12A Pukenui Road.

Proposed amendment: Delete *Quercus canariensis* from botanical name, delete Canary Oak from common name and change number of trees from 10 to 9.

Notification error - directly affected persons were not notified.

15. ID 870- 117 Shelly Beach Road, Herne Bay

Proposed amendment: Add 2 to number of trees.

Notification error - directly affected persons were not notified.

16. ID 239- 349 St Heliers Bay Road, St Heliers

Proposed amendment: Change *Quercus spp.* to *Quercus robur* and change oak to English Oak.

Proposed amendment: Change in common name to add 2 to Kauri and 2 to Totara

• Notification error- directly affected persons were not notified.
