# Errata Memo

**Subject: Amendments to the Auckland Unitary Plan (Operative in Part) Version following Commissioner decisions on submissions on Proposed Plan Change 14**

Council has identified one consistency issue in the text shown in [Appendix one of the Decision version of Proposed Plan Change 14](#). The text shown in Appendix one does not reflect the decision of the commissioners. Further text is required to be deleted or amended in Appendix one to reflect the intended outcome. This errata memo is to show the correct provisions in the [Decision version of Proposed Plan Change 14](#).

## **Amendment 1: E23 Signs**

Paragraphs 76 to 79 in Plan Change 14 Decision report indicated that the Commissioners accepted the relief sought by Outdoor Media Association of NZ Inc which was not to apply restricted discretionary activities to Standard *E23.6.1. Billboards in zones*. Council's reporting planner agreed that this change was appropriate. The decision amendments in **Appendix one** do not represent a complete amendment and a further amendment is required.

In Attachment 1, the Decision version of Proposed Plan Change 14 should have the below struck out (**red text** highlights the correction):
