

Proposed Plan Changes 14, 15, 16 and 17

Navigation Guide

This guide is designed to help navigate through the materials and attachments associated with this series of plan changes. The documents associated with the plan changes are detailed below. We encourage you to read the Section 32 evaluation report before making a submission.

Overview of the Plan Changes

Proposed Plan Changes 14, 15, 16 and 17 seek to improve the consistency of provisions within the Auckland Unitary Plan (Operative in part) (**Unitary Plan**), through addressing identified technical issues and anomalies.

The proposed plan changes address identified technical issues within Chapter D Overlays, Chapter E Auckland-wide, Chapter F Coastal, Chapter H Zones, Chapter H Definitions and Chapter M Appendices, and also address mapping anomalies within the Unitary Plan Viewer.

In accordance with section 86B(3) of the Resource Management Act 1991 all of the proposed plan change rules have immediate legal effect.

Explanatory note - not part of proposed plan change

The proposed changes to the Auckland Unitary Plan seek to improve the consistency of provisions. Chapter F Costals, Chapter J Definitions, Appendix 7 and the viewer of the Auckland Unitary Plan (Operative in part).

Plan change provisions

Amendments proposed by this plan change to the Austriand Unitary Flan are shown with <u>underline</u> for new text and observable where existing text is proposed to be deleted. The use of ... indicates that there is more text, but it is not being changed. These are used when the whole provision is too long to be included.

Proposed Plan Changes 14, 15, 16 and 17

The proposed plan changes show the proposed amendments to the Auckland Unitary Plan – Operative in Part. This is the document that is called the 'plan change'.

Plan Changes 14, 15 and 16 propose amendments to the text. The proposed additions are shown in <u>underline</u> and the proposed deletions are shown in <u>strikethrough</u>.

Proposed Plan Changes 14 and 15 include rule amendments that have immediate legal effect upon notification under section 86B(3) of the Resource Management Act 1991. In Plan Change 14, where a proposed amendment has legal effect upon notification of the plan change, this is shown in grey highlight. In Plan Change 15, all of the proposed amendments have legal effect upon notification of the plan change.

Plan Change 17 proposes amendments to the Unitary Plan Viewer and consequential amendments to certain precinct diagrams within Chapter I Precincts. The plan change PDF shows the property affected by the change in black hatching with text which describes the proposed amendment to the viewer.

Plan Change 17 includes amendments that have immediate legal effect from notification.



Using the Auckland Unitary Plan

Annotations in the Unitary Plan PDFs and Unitary Plan Viewer

Amendments proposed through Plan Changes 14, 15, 16 and 17 to text and diagrams have been annotated in the respective chapter and section versions of the Unitary Plan. Proposed spatial changes of Plan Change 17 have also been annotated in the Unitary Plan Viewer.

PC 15 s86B (3) Immediate legal effect (See modifications) Plan Changes 14 and 15 both include rules which have immediate legal effect from notification. Rules that have immediate legal effect from notification are annotated in the Unitary Plan with a blue annotation bar and text 'PC14 s86B(3) Immediate legal effect (see modifications)' or 'PC15 s86B(3) Immediate legal effect (see modifications)'.

PC 15 (See modifications)

The remaining proposed amendments in Plan Changes 14, 15, 16 and PC17 will not have effect until a decision is reached and is beyond legal challenge.

These are annotated in the AUP with a blue annotation bar and text 'PC14 (see modifications)', 'PC15 (see modifications)', 'PC16 (see modifications)' and 'PC17 (see modifications)'.




Proposed spatial changes in Plan Change 17 are annotated in the Unitary Plan Viewer with a black diagonal key. Please follow the instructions below for how you can see proposed spatial changes subject to a plan change in the viewer.



How to view proposed spatial changes in the Unitary Plan Viewer

- Go to the Unitary Plan Viewer
 https://unitaryplanmaps.aucklandcouncil.govt.nz/upviewer/
- 2. Once you are in the viewer, click on 'Unitary Plan Appeals and Plan Modifications' under 'Legend'.
- 3. Then, expand the list (by clicking on the arrow pointing down next to the title) and click on 'Modifications'. Sometimes the modifications and plan change box has a tick in them (see image below).
- 4. To only see changes related to the plan changes, untick all other boxes and keep plan change box ticked. This will turn on the layer so you can view which properties are subject to the plan change.
- 5. Use the address search tab to search by property. When you specifically click on a property results of the property will pop up that will tell you which plan change does it relate too.



Note that not all spatial changes in Plan Change 17 will be shown in the Unitary Plan Viewer (i.e. changes to diagrams and precinct plans – you must go back to the respective chapters/sections of the PDF documents).

What does immediate legal effect mean?

Certain types of rules in the Unitary Plan have immediate legal effect from the date of notification of the respective plan change, provided that they fit within section 86B (3) of the Resource Management Act 1991 (RMA). Immediate legal effect means that a rule must be complied with from the day the rule is notified within a plan change.



Making a submission

If you would like to make a submission on Proposed Plan Change 14, 15 or 16 you can complete a submission form online or download a submission form which follows the prescribed form from Council's Unitary Plan website at www.aucklandcouncil.govt.nz/unitaryplan under the Unitary Plan Modifications / Proposed Plan Changes headings.

Alternatively, copies of the submission forms can be collected from any Library or council office and either posted to Auckland Council or emailed to unitaryplan@aucklandcouncil.govt.nz.

To make a submission on Proposed Plan Change 17 you must have been served notice as a person or party affected by the proposed plan change. If you have been served notice you can complete a submission form online or download a submission form which follows the prescribed form from Council's Unitary Plan website at www.aucklandcouncil.govt.nz/unitaryplan under the Unitary Plan Modifications / Proposed Plan Changes headings.

Alternatively, copies of the submission forms can be collected from any Library or council office and either posted to Auckland Council or emailed to unitaryplan@aucklandcouncil.govt.nz.

Please note that the closing date for submissions to all four plan changes is 31 January 2019.
