1. South Epsom Planning Group Inc ("**SEPG**") wishes to be a party under section 274 of the Resource Management Act 1991 to the following proceedings:
  - a. An appeal by Kainga Ora – Homes and Communities ("**Appellant**") against a decision of the Auckland Council ("**Council**") on Plan Change 26 to its Auckland Unitary Plan ("**AUP**").
2. SEPG made a submission and further submission about the subject matter of the proceedings.
3. SEPG is not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.
4. SEPG is interested in all of the proceedings.
5. SEPG is interested in the following particular issues:
  - a. The Appellant's relief seeking the decline of the plan change.
  - b. The amendments proposed to Standard D18.6.1.3 (Yards).

  - a. SEPG supports the Council's decision to give the standards in the Special Character Area Overlay precedence over standards in the underlying zone.
  - b. SEPG supports the Council's decision to apply a 3 metre depth on rear boundaries in Standard D18.6.1.3 (Yards) to all sites in the Special Character Area Overlay – Residential.
  - c. SEPG considers that much of the relief sought by the Appellant is out of scope with respect to the stated purpose(s) of PC26.
7. SEPG agrees to participate in mediation or other alternative dispute resolution of the proceedings.
