HI all

Some meeting minutes from today if you could please correct any omissions.

The tracking over the pipeline shown in the aerial photo was Ute tracking completed during HEB occupation in 2018/19. Only construction access over the pipeline was via swamp pad with watch over by John Seagar at Park Estate Road.

#### **Design Constraints:**

1. 1.2m min cover in rural areas, potentially deeper under carriageways. Correct.

- 2. 3m max cover preference. 3mtr should be consider max cover, ideal cover is 2mtrs. The deeper it is the wider free area we require to access it.
- 3. SW, WW clearances/separation 1.5m. Large concrete SW, WW pipes should be out side the easement, we can accommodate a small incursion on a case by case for a chamber etc, HDPE pipe is our preference.
- 4. Flexible utilities (comms, power) 500mm clearance at cross overs / separation. Yes at 90 degree crossings, running parallel but depending on voltage should be 3mtrs away.
- 5. Located in berm is preference, then carriageway (footpath over). Road reserve will need to be widened in this case. Correct
- 6. Easement to be completely within the road reserve total width 12m (6m either side of pipe centreline). First gas do not want easements in multiple fronts of lots (multiple owners). Permanent buildings not to be in the easements as preference. Correct
- 7. Streetlighting need to be clear. Correct
- 8. Therefore it is likely that carriageway centre is likely to be best location to alleviate above. Our first preference is in the berm using the easement as a green belt or cycleway.

#### **Protective Slabs**

- 1. U slabs mesh reinforced concrete for 2 sides, off the shelf precast. Not sure if they are off the shelf, can provide a sketch for general info if required.
- 2. Tapex slab HDPE for the top cover only, yellow cover. Correct and cheaper for your client than concrete, we still need to confirm soil conditions.

### **Construction Loading**

- 1. Construction loading for road construction Up to 6T vibrating roller and 12T non vibrating. Correct
- 2. Existing line is 200mm steel, Up to 86 bar pressure (1500psi). Correct it's a major gas transmission pipeline.
- 3. Safety assessment has been completed by First Gas. Correct

4. CivilPlan need to firm up design so that final safety measures can be confirmed

The methodology to build the road will use a 20T excavator over the gas main, to load out material to 6 wheelers sitting off to the side, off the road alignment in the berms. Road metal will be compacted with the rollers as described below.
