



At its Policy and Planning Committee meeting on 22 May 2025, the Auckland Council decided to accept all the Independent Hearings Panel's recommendations on submissions on Plan Change 78: Intensification as they relate to the City Centre.

All City Centre related provisions are deemed approved by the Council's acceptance of recommendations. The provisions will become operative on 6 June 2025.

The updated Auckland Unitary Plan may be viewed on the Council's website from **6 June 2025** when the relevant City Centre provisions become operative.






