# Private plan change application – 546 and 646 McNicol Road and 439 Otau Mountain Road, Clevedon – further information request

# 1. Landscape and Visual Effects

2. The one drive link includes a report from John Goodwin of Boffa Miskell. Mr Goodwin concludes that:

In my opinion relevant AUP objectives and policies that require the protection of the Wairoa River Gorge ONF can be met with approval of the proposed plan change

# 2. Acoustics

- 3. The one drive link includes a response from Siiri Wilkening of Marshall Day.
- 4. As an observation the clause 23 matters look to address the issue of acoustics and vibration at a resource consent level of detail rather than associated with a plan change. In this respect it is noted that the Quarry Zone contains a specific noise and vibration standard in H28.6.2.1 and H28.6.2.2. This is not proposed to be amended by the private plan change and would apply to the zonings proposed by the request.




8. The meeting minutes for those four meetings are in the one drive link. As indicated in the meeting minutes, the private plan change was discussed at all of those meetings (and prior meetings). There was an undertaking at those meeting that NTKT would provide written comments, but these are still to come. Written comments have been requested via meetings or emails on:



- 9. Yes, the application reviewed the following available management plans:
  - Ngai Tai Ki Tamaki Management and Development Plan;
  - Ngāti Pāoa Resource Management Plan (May 1996) / Ngāti Pāoa Interim Iwi Management Plan (2013).
- 10. No relevant matters to the plan change were identified.

### 5. Quarry Buffer Area Overlay

- 11. The Quarry Buffer Area Overlay is not proposed to be altered. The Overlay addresses reverse sensitivity from subdivision and land use development of noise sensitive activities in proximity to a quarry.
- 12. The Overlay does not uniformly run 500m around the existing Quarry Zone as during the 2016 AUPIHP hearings (when the extent of quarry zone was determined) the operator did not seek to extend the Overlay beyond that which was notified with the PAUP. Consequently, the Overlay actually applies 500m from the current extent of the mineral extraction activity as it relates to the north and north-west (as opposed to the boundary of the current Quarry Zone). Therefore no change is required to the overlay to the north or west to align with the shift in the Quarry Zone proposed by the private plan change.
- 13. Because of the unique locational factors (including the ONF, SEA on the western slopes of the Wairoa Gorge, public ownership of part of the western slopes of the Wairoa Gorge) and that the applicant owns land south of the quarry site it is not proposed to extend the Overlay to the south. Only one dwelling exists to the south, and the remainder of the landform is not considered to be readily developable with residential dwellings or rural lifestyle subdivision. The applicant's land ownership is illustrated below.
