Hi Bal,

The Plans & Places team have reviewed your s 20A request and are satisfied that this is an error that should be corrected. They are also of the view that the quarry buffer area overlay will have to be corrected to align with the new zone boundary.

A memo has been drafted to set this out, which will then get signed off by the Manager Planning – Aucklandwide (most likely tomorrow). We can then share a copy of this memo with you.

In terms of when changes will formally be made to the maps, the next set of modifications are scheduled to go through in February of next year, and this change would go through at that time.

I trust this assists, but if you need anything else in the meantime please let me know. Otherwise, I will send you a copy of the signed off memo as soon as I get it.
