PERCHES (878 acres 2 roods 9 perches) more or less being part of ..... Allotments 26, 27, 28 and 29 of the Parish of Otau and being the whole of the land comprised and described in Certificate of Title Volume .... 2083 Folio 11 of the Register Book at Auckland SECONDLY ALL THAT ... piece or parcel of land containing FOUR HUNDRED AND SEVENTY-EIGHT .... - 2. THE transferor will erect a gate at the northern end of the rightof-way and such gate shall except when actually in use be kept locked. The transferor shall on each occasion before opening the gate advise . the Council's ranger stationed nearest to the gate of his intention to do so and will ensure that the same is closed after use.
- 3. THE transferor shall use the right-of-way reserved hereby for the. purpose of stock drowing and mustering under the control and to the .. satisfaction of the Council and also for the purpose of transporting . fertilizer and fencing materials in dry weather with restricted loading so as to avoid damage to the surface of the servient tenement.
- 4. THE transferor in the exercise of the rights hereby reserved will cause as little damage as possible to be done to the surface of the .. servient tenement and will from time to time forthwith repair and make good all damage done in the exercise of his rights under these ...... presents.

THE transferor shall exercise his rights hereunder and use the ... lands only for the purposes and in the manner hereinbefore set out at. his own risk in all things and will indemnify and keep indemnified the Council from and against all claims damages costs and expenses which . the transferor may sustain by the exercise and use of the said rights. AND IT IS HEREBY AGREED AND DECLARED that the transferee shall be .... under no responsibility whatsoever to maintain the surface of the .... servient tenement.


