Notice of Requirement for designation for Paerata Connections (NoR 3) for two new transport corridors including active mode facilities.

### **Notice of Requirement Paerata Connections (NoR 3)**

Auckland Council has received a notice of a requirement for a designation from Auckland Transport as the Requiring Authority, for public work.

The requirement is for the construction, operation and maintenance of two new transport connections including active transport facilities and associated infrastructure. One transport corridor is located between the two extents of Sim Road, Paerata across the North Island Main Trunk Rail Line and the second connection is between Paerata Rail Station and Sim Road, Paerata. The proposed work includes:

- Construction of new transport corridors including active mode facilities;
- Associated works including intersections, bridges, embankments, retaining walls, culverts, stormwater management systems;
- Changes to local roads, where the proposed work intersects with local roads; and
- Construction activities including construction areas and the re-grading of driveways.

The site to which the requirement applies to an area of land of approximately 109,399 square meters located in the Paerata area of the Pukekohe Transport Network. The requirement applies to 13 land parcels (not including legal roads or railways) (refer to attachments A and B of the Form 18).

#### Making a submission on the notice of requirement

Any person or organisation may make a submission on the notice of requirement, but a person who is a trade competitor of the requiring authority may do so only if that person is directly affected by an effect of the activity to which the requirement relates that –

- (a) Adversely affects the environment; and
- (b) Does not relate to trade competition or the effects of trade competition.
