#### 1.0 Executive summary

Under the provisions of the Auckland Regional Amenities Funding Act 2008 (the Act), the Funding Board is required to produce a draft Funding Plan, which is subject to public consultation.

The Draft 2022-2023 Funding Plan was approved for publication by the Funding Board on 9 November 2021.

The Act requires that the plan be available for public comments for a period of one month. The plan was published on 7 January 2022, and the submission period closed at 5PM on Tuesday, 8 February 2022.

A total of five (5) submissions were received. A copy of all submissions received is attached in Addendum 1.

There are no submitters wishing to make further oral submissions to the Board.

Oral submissions were / are set down to be heard on Tuesday, 15 February 2022, commencing at 10:00AM.

Following consideration of both the written and any oral submissions, the Funding Board will determine whether changes need to be made to the final version of the 2022-2023 Funding Plan.

Once the final allocation of grants has been confirmed for 2022-2023 the total levy will be determined. Details of the final version of the 2022-2023 Funding Plan and the proposed levy will be forwarded to Auckland Council to consider and approve the levy at a future meeting.

#### 2.0 Narrative

In the interests of transparency, the Act requires the Funding Board to publish a Draft Funding Plan for public consultation.

The Draft 2022-2023 Funding Plan detailing the proposed total levy and the provisional allocation of grants to the specified amenities was approved for publication by the Funding Board on 9 November 2021. The Draft Funding Plan was published on 7 January 2022. Two public notices were placed in the NZ Herald during January 2022 advising that the plan was available for inspection and comment. The Draft Funding Plan was also available for download directly from the website (arafb.org.nz) which also contains details of the board's meetings and previous funding plans and annual reports.

Copies of the plan were specifically distributed to all the Specified Amenities listed in the Act as well as Auckland Council.

A total of five (5) submissions have been received. A high-level summary of each submission is detailed in the schedule at the end of this report.

There are no submitters wishing to make an oral submissions. The hearings have been set down to commence at 10:00AM on Tuesday, 15 February 2022.

Following consideration of both the written and oral submissions the Funding Board will determine whether to make any changes to the final version of the 2022-2023 Funding Plan including the allocation of grants.

A final recommendation on grant allocations and the total levy requirement for 2022-2023 must be made and forwarded to Auckland Council for consideration in March 2022.

Auckland Council will meet to consider and approve/not approve the proposed levy for 2022-2023. If Auckland Council approves the levy, the Funding Board will meet on 29 March 2022 to fix the levy for 2022-2023 and adopt the Funding Plan. If Auckland Council resolves not to approve the levy, the matter will immediately revert to arbitration in accordance with the provisions of Auckland Regional Amenities Funding Act 2008. Irrespective of which course of action occurs, the levy must be fixed no later than 30 April 2022.

#### 3.0 Financial Impacts of Submissions

Within the five submissions received there are no requests for changes to the allocation of grants.
