ARAFB - General

- Copies of the Balance Sheet and Profit and Loss account to 31 October 2022 are attached. During this quarter the levy was received in full and on time from Auckland Council. The grants were distributed to the eight amenities on the earliest date permitted.
- Reserves Policy The board passed its Reserves Policy in June 2020 with the intention being that a decision would be made on an annual basis whether funds would be allocated to a reserve to be held for purposes to be determined by the board. The board may wish to consider this option.

Specified Amenity Quarterly Reports to 30 September 2022

3. Quarterly reports to 30 September 2022 have previously been distributed to directors under separate cover.

Specified Amenity Annual Reports to 30 June 2022

4. Annual reports and financial statements were received from the Specified Amenities by 30 September. The reports have been previously circulated to directors for review.

2022 Annual Report and Audit

- 5. The Office of the Auditor General, communicating through Audit New Zealand, has advised that due to on-going staff resourcing matters, it needs to prioritise audits for central / local or other government related agencies needing sign-off for banking, stock market or other securities related matters. The 2022 audit will therefore commence on approximately 17 November 2022, with a proposed completion date of no later than 24 December 2022.
- **6.** All information needed by Audit NZ to commence / undertake the annual audit will be provided to Audit NZ in accordance with the agreed timetable.
- 7. As the Funding Board will be unable to meet the statutory deadline of adopting the audited financial statements by 30 Nov 2022, the financial statements will again be noted that the delay has been due to circumstances beyond the control of the Funding Board.
- 8. Likewise, if the audit is not completed and the Annual Report cannot be adopted by 31 December 2022, Audit NZ or the OAG will contact Charities Services to advise the reason for the board being unable to submit it's annual return by the 31 December 2022 deadline.

The administration budget increased in 2022-2023 having remained unchanged for three consecutive years as part of the expenditure constraints implemented in support of Auckland Council budget pressures.

The Draft 2023-2024 Funding Plan is currently being prepared ready for publication on/about 19 December 2022 seeking public submissions on the proposed plan.

Review Board Member Remuneration for 2023-2024

The honorariums paid to Funding Board members must be reviewed annually in accordance with the provisions of the Auckland Regional Amenities Funding Act. The Draft 2023-2024 Funding Plan must provide details of the proposed levels of remuneration to be paid to board members.

The honorariums for directors of the Funding Board must be approved by Auckland Council after considering a recommendation from the Funding Board. No changes to the rates of honoraria occurred in 2020-2021 or 2021-2022 due to the board wishing to constrain expenditure arising from the impacts of COVID-19 on the financial performance of Auckland Council.

The proposed board member remuneration for 2022-2023 is as follows:

The Funding Board has, and continues to, operate in a fiscally prudent manner and strives to minimise its costs wherever possible. If approved by Auckland Council, the rates would be payable from 1 July 2023.

Auckland Council has previously requested that the honorariums be reviewed and adjusted annually, rather than every two or three years. In light of the current economic environment arising from the COVID-19 pandemic, it was recommended that the board forwent any adjustments to the honorariums for two consecutive years, but noted that adjustments would be considered for 2022-2023 and subsequent years.

It is necessary for the board to adopt a level of remuneration to recommend to Auckland Council for consideration and approval, and for these rates to be detailed in the Draft 2023–2024 Funding Plan when it is published for public consultation in December 2022.

Subject: 2022 Annual Report

Following a series of informal discussion with the Auckland based Audit New Zealand (ANZ) Audit Director, the Advisory Officer has agreed to supply all the information needed to undertake the 2022 Audit on or by 17 November 2022.

This decision arises from ANZ continuing to experience personnel shortages largely attributable to the lingering impacts of the COVID-19 pandemic.

The Office of the Auditor General (OAG) has directed ANZ to focus undertaking audits on those central, local and other government related organisations that require audits to be completed to meet stock exchange, banking or other situations where non-compliance with audit requirements could have serious detrimental impacts on the business.

Although ANZ intend to complete the audit by 24 December 2022, ANZ acknowledge that the Funding Board will for the second year running be required to add additional explanations to the final annual report, explaining that the delays were caused by Audit New Zealand.

A further matter to consider is that the last scheduled meeting of the Funding Board is 22 Nov 2022, with the next meeting then not being held until approximately 14 February. It is unlikely that the board will be able to adopt the final 2022 Annual Report until at least 14 February 2023.

The OAG will communicate directly with Charites Services advising of the delays and will seek an extension of time for the Funding Board to furnish its 2022 annual return.

Additionally, all eight Specified Amenities and Auckland Council will be advised of the delay in completing the 2022 audit and the publication of the final 2022 Annual Report (including the financial statements).

Recommendation:

That the Funding Board:

- A) Note that Audit New Zealand has advised that it will not commence the 2022 audit until approximately 17 November, with an intention of completing the audit by 24 December 2022.
- B) Instruct the Advisory Officer to send copies of the Draft 2022 Annual Report (when available) to the Specified Amenities and Auckland Council, clearly noting that due to Audit New Zealand delays the final adopted version will not be available prior to 14 February 2023.
