

#### Types of feedback


- 1. online submissions, hard copy forms, emails and letters.

#### Written submissions (or pieces of feedback)

Out of 11,550 pieces of feedback received regionally, 445 of pieces of feedback were from people living in the Hibiscus and Bays area.

2018 Census data - age distribution







#### DRAFT Local board priorities taken to consultation


- a) renew sports fields and connected facilities, such as lighting, around Freyberg, Stanmore Bay, Silverdale War Memorial and Victor Eaves Parks
- b) continue with Te Ao Māori and community-led conservation project which brings local iwi and volunteer ecology groups together to share practical knowledge of our area
- c) investigate and design new dedicated dog parks within the local board area
- d) start planting large specimen trees as part of the Urban Ngāhere (forest) programme in selected reserves
- e) support our Business Associations with an economic development fund and assisting Silverdale's intention to establish a new Business Improvement District
- f) establishing new tracks in Bushglen Reserve in conjunction with expert advice from arborists

#### **Local board priorities – key themes**

- Providing better walkways and cycleways most supported
   "We lack good bicycle access in our area, painted...roads don't count"
- Environment, coastlines and waterways- most supported although mixed support for the Urban Ngahere project

"maintain our coastal walks and beaches"

 Te Ao Maori and community led conservation project – a lot of negative comments, although submitters seemed confused with co-governance issues

"drop the Maori consultation thing, this is a rewrite of the treaty"

Dog parks - very little support
 "Do not need dog parks at this time" "why not dedicated dog beaches"



# Consultation feedback received on regional topics in the proposed Annual Budget 2022/2023



#### Annual Budget 2022/2023: regional topic

The proposed Annual Budget 2022/2023 sets out Auckland Council's priorities and how to pay for them. Submitters were asked to respond to four key questions on regional topics outlined below:

- 1. Climate
- 2. Budget Pressures
- 3. Waste Service Standardisation4. Operating Spending Prioritisation




#### 1. Climate - page one

Aucklanders were asked about a proposed climate action package which will be funded by a targeted rate. The climate action package includes investments in low-carbon public transport, active walking and cycling networks; and urban ngahere (forest) canopy cover.

This is proposed to be funded through \$574 million from a targeted rate over the next 10 years as well additional funding from government co-funding.

#### **Typical support comments:**

"Because there should be safe cycle/pedestrian options for all roads"

"Got to look after our planet, we've only got one shot at this"

"let's do all we can to support...our children, their children and their children after them."

#### **Typical do not support comments:**

"why make the ratepayer pay? This should be handled by the government"

"Focus on big polluters such a China"


#### 2. Budget Pressures

Aucklanders were asked about a range of levers proposed to manage on-going budget pressures. Council are forecasting a budget shortfall of \$85 million for 2022/2023 due to ongoing impacts of COVID-19 on revenue and growing inflationary pressure.

A range of levers are proposed to manage the budget pressures including:

- Using the Government's Better Off support package funding
- Changing the timing of some capital spending
- Implementing cost reductions in the form of efficiency savings and a potential reduction in some services
- Keeping the previously agreed general rates increase of 3.5 per cent for 2022/2023 and;
- Continuing work on the sale or long-term lease of non-strategic assets as required.




#### 3. Operating Spending Prioritisation

Aucklanders were asked to provide feedback on a proposal that would see council prioritise operating spending to help manage on-going budget pressures. A set of criteria to be used when making decisions about cost reductions, including those that could reduce, stop or change some services, was proposed.

The proposal involves implementing \$15 million of additional permanent cost reductions in the form of efficiency saving and low-priority service reductions across the group in 2023/2024, growing to \$30 million per annum from 2024/2025 onwards.


#### 4. Waste Service Standardisation

Aucklanders were asked about a proposal to standardise waste services and charges across Auckland. The proposal would involve a move to a region-wide rates funded refuse collection service and see a choice of three bin sizes (with different pricing for each) to accommodate different household needs.

Auckland Council are also proposing to include standardising which properties can opt-out of waste management services and charges across Auckland.

#### 4. Waste Service Standardisation – Question 4B

Auckland Council are also proposing to include standardising which properties can opt-out of waste management services and charges across Auckland. These are the responses from your local board area.

#### 5. Other Issues – comments on other topics

Feedback on other issues, including:

- General financial strategy (44 responses –most supportive, and urging caution with asset recycling, happy with further borrowing BUT no further rates increase)
- Transport (33 on walking and cycling, 23 on footpaths, 27 on public transport, 2 on parking almost all supportive of better funding for these areas)
- Local board decision-making over local community services (five responses)





# Topic 3: Recommendations on local matters



#### **Local board advocacy - Hibiscus and Bays**

What is the key position that the local board wishes to adopt, given the constraints of this year's budget?



Boat ramps – investigating provision, with an intent to creating a regional strategy for investment, development and usage of boat and water-craft launching areas



Compliance – ability to issue infringements for overnight camping in reserves



Seeking funding for the prioritized but unfunded project to construct a Bus terminal at the Whangaparaoa end of Penlink, in order to allow for Public Transport usage from day 1



Investigation of an omnibus control over set-netting in beaches around the Hauraki Gulf
