For many of the young people we work with the first contact point is through the Helpline and our volunteer counsellors. Many of the young people are vulnerable – disadvantaged, disillusioned, disengaged - and their situation is exacerbated by the lingering COVID shadow and the extreme weather events of early 2023.

Our Helpline is staffed by 120 volunteers who processed 145,927 contacts from young people in need last year. They are only able to do this vital work because they receive comprehensive training and support.

Mental health remains a key issue for young people with 3 in 4 young people agreeing mental health is a problem in the most recent research (Kantar Public 2023). Last year 1,576 young people from Waitakere Ranges needed our help, with COVID producing greater stress and distress for our rangatahi.

We have to be able to provide the best possible support for young people in need and we do this best when we have a well trained team of volunteers and support staff.

The community benefits when we are able to support young people through their period of distress and emerge with a positive plan for the future and can help build a resilient community.

We have a strong commitment to diversity recognising that our minority communities, including Maori, Pasifika and Rainbow youth, disproportionately experience mental health issues and are less likely to seek help.

A strategic priority is to hold an equity focus on Maori, Pasifika, Rainbow, Asian, Migrant and Refugee youth and young people with disabilities.

We are advocates for youth focus, youth voice and youth choice and providing leadership to ensure young people are prioritised and invested in. Recognising and addressing inequities and upholding safety is very important to us.

### Amount requested: \$3000.00

**Requesting grant for:** 

We are requesting \$3,000 as a contribution to the Waitakere Ranges share of \$3,775 of the annual budgeted costs of \$121,000 for training and providing clinical supervision for our volunteer counsellors who staff the Youthline Helpline in support of the young people of the area and their whanau.

### If part funded, how would you make up the difference:

We would not amend our plan as such. Rather we would continue being extremely proactive in applying for funding from a wide range of funders. The total cost of the Youthline Helpline will be \$1.576m this year. We receive funding of \$226,000 from Oranga Tamariki and MSD contracts meaning we have to fundraise over \$1.350m each and every year.

Since the arrival of COVID many of our funders have a reduced capacity to provide funding. At a time when young people need our service more than ever we are hugely dependent on those organisations who can provide funding.

**Environmental benefits:** Wetland restoration - with only 9% wetlands left and Matuku Link at the head of the environmentally significant (and Auckland's largest) Te Henga wetland this is vital habitat for threatened species like matuku (bittern), puweto (spotless crake), the reintroduced pateke (brown teal) as well as pekapeka touroa (longtailed bats), tuna (eels), weta, inanga and many forest birds who use the wetland as a safe corridor or the edges as feeding ground.

A number of young adults have used volunteering at our project as a stepping stone to gain job experience, knowledge and a good reference for employers.

### If part funded, how would you make up the difference:

We'd go for the radios (1675) - really necessary in our terrain, the ones we used to borrow are unavailable and the cheaper versions we had do not cover the whole 5 hectares, including the wetland areas. Then the AED (\$2964) as most our volunteers are retirement age and heart issues spike in that age range. The high viz (\$406) are really useful when we do our community events - for volunteer parking helpers, tour guides as well as with our education program. Hosting with food & coffee is manaakitanga - necessary for many reasons.

No cost for volunteers to participate. A small cost for schools however that is outside this funding application and usually separately fundraised for to lower that barrier.

The Handlers - a show written by Alvie McKree (Ngapuhi, Ngati Kahu ki Whangaroa, St Vincent, Barbados) and developed as part of Te Pou Theatre's Playwright's Programme - presents a fictionalised account of Māori experiences while working at the Crown Lynn Pottery factory in New Lynn in the 1970s. As such, the play offers the perfect opportunity to showcase te āo Māori, Māori actors and Māori technical practitioners such as lighting designer Jane Hakaraia (Ngāti Raukawa).

This project supports this Whau priority by providing a way for Whau community members to easily access an artistic presentation that tells the story of Māori experiences in 1970s New Lynn.

The project features the iconic Crown Lynn factory, reminding all audience members of this highly significant institution, and the works it created.

Not only does this show's presentation empower those who work on it by providing a voice for historical minorities, it will bring together diverse audiences from across West Auckland and no doubt provoke discussion and engagement between these patrons.

Te Pou Theatre has just completed a three million dollar build and fitout inside Shed 1 at Corban Estate Arts Centre, opening it's doors for artists and arts organisations to stage events for audiences. We have surveyed audiences since the first event (Te Pou Theatre's own show Hemo is Home) and statistics are showing a consistent result: 33-35% of our audiences come from West Auckland, 67% of our audiences are Māori.

Te Pou Theatre, by providing and promoting a platform for this project, is fulfilling several of its core whāinga as a leader within the performing arts landscape of Aotearoa, including:

- To create and sustain a programme of Māori storytelling
- To create and sustain a Māori led performing arts venue

- To support and encourage the growth and development of the Auckland Māori performing arts sector

- To increase Māori community engagement with the performing arts
- To increase diverse community engagement with the performing arts
- To connect all communities of Aotearoa to Māori performing arts
- To support the reclamation and revitalisation of Te Reo Māori through the performing arts

Our performing arts venue is kaupapa-Māori led, with this project expected to employ 14 Māori out of a cast, crew and producing team of 18, and with all leadership roles being Māori.

This project engages emerging and established Māori creatives and producers, providing pathways for those Māori to build their skills and pursue sustainable careers as leaders within the performing arts industry.

- Te Whau Local Board have initiated the Pou Whākairo project for Rata Street New Lynn and have engaged Haumi Ltd to adhere to the project
- The design element has been submitted and accepted by both Te Whau Local Board and Te Kawerau ā Maki
- Haumi is now an approved Council Vendor and is applying to be a Vendor for future Project Management for projects of this type ie – The Te Ātatū Marae & Te Henga Marae Projects
- I meet with Advisors from the three Boards once a month to strategise and plan the work scheduled objectives

#### **Citizenship Ceremony**

Three years of planning found fruition in October this year to hold the first citizenship ceremony on a Marae. It was an amazing successful day with a cross section of DIA, Council Events, Local Board Advisors and Hoani Waititi Marae working together to initiate and run this day

This was a pilot programme to which future budgets will be based on

Advisors have met with DIA and Council to decifer the budget costs and DIA will be meeting with the three Local Boards in Jan-Feb 24 to explain the budgetry costs and future budget forecast









#### Rā Mokopuna & Rā Kaumatua

The three West Auckland Local Boards are in their fourth year of funding the West Auckland Rā Mokopuna and Rā Kaumatua that is run at Te Kura Kaupapa Māori o Te Kōtuku Rānui

The Rā Mokopuna attracts over 600 participants on the day and has been a great success

Te Rā Kaumatua attracts 50 Kaumatua and is a beautiful day of interaction between our elders and rangatahi

#### Ngā Roopu Kaumatua in West Auckland

We know have 4 established Roopu Kaumatua in West Auckland

It was a beautiful day of interaction, fun and laughter









#### **Immigration and Connecting Communities**

We have hosted new immigrants & refugee services in conjunction with Kāhui Tū Kaha & HOPE Foundation to implement a protocol of interaction with Māori for new immigrants

Around 80 new immigrants attended the hui on the Marae

It was a great day and a great success. This is a continuing relationship being developed with the objective being to entrench this as standard practice and protocol for new immigrants coming into NZ as rufugees

#### **NZMA Trades Training**

We are in our fourth year partnering with Tops Education NZMA Trades Training which was initiated as a post covid education strategy and response supported by Waitākere Ranges Local Board

The NZMA Trades Training Campus was the most most successful campus in NZ with this years student completion rate and movement into employment and apprenticeships sitting at 80%

Negotiations for resigning with the Marae for a continuation of service are tabled for Feb 24

#### **Henderson Police Station**

The Henderson Police Station Carved Tomokanga Project was a huge success

#### **Beautify Glen Eden project**




#### Te Tāngaengaetanga o te Mauri Tangata

The Balance of Spirituality

The traditional carved entrance way was comissioned for the Waitematā District Headquarters in Henderson with the intent to give the station a more welcoming presence, for all visitors.

It is a celebration of the relationships that have been built with Iwi Māori in our district and our desire to continue to foster and strengthen those, and new relationships

It is also a bold statement of accountability to the community in terms of responsiveness to Māori – in line with our core New Zealand Police value, of Commitment to Māori and the Treaty.






## Hinenuite-pō

Hine-nui-te-pō is the ancestress and guardians of the underworld, and the transition from one life's realm to another.

Hine-nui-te-pō resides as the Tekoteko of the Whare to remind us of mans continual need to challenge and push the boundaries of life.



The Mokomoko (lizard) represents Maui who tried to stop death by entering Hine-nui-te-pō to eat her heart. Again displaying mankind's consistent challenging of life's boundaries.

Ultimately Hine-nui-te-pō crushed Maui in between her legs reminding us that the circle of life cant be manipulated by man.

The bottom carved face represents Te Kūwatawata, one of the 70 children of Ranginui & Papatuānuku who is one of the guardians at the gateway of the underworld between the living and spiritual worlds.





# Mauri Atua

The Kōwhaiwhai patterns represent the life force of the Gods descending from

> the Heavens to Papatuānuku -*Mother Earth*.

The joining of the celestrial energies of the heavens to the earthly realm.



### Tāne-te-Wānanga

The left side of the Tomokanga represents Te Ira Tāne - *the male lineage.* 

Fane te Wananga represents Tane being chosen by the Apa Whatukura -Māori male angels, to ascend the heavens to get the three baskets of knowledge to bring down for mankind.



# Whiro

Whiro is the older brother of Tāne.

As the older brother, Whiro thought that he should have been chosen to get the three baskets of knowledge from the heavens and decided to ascend the heavens with his Ope Tauā - *war party*, to kill Tāne. A battle commenced in the Heavens which was named Te Paerangi. Tāne and his Ope Tauā defeated Whiro. Whiro and his Ope Tauā were relegated to Rarohenga - the domain of the Underworld as a



Kaitiaki or guardian at the gateway between the realm of the living and the dead with Te Kūwatawata.



# Whatukura

The Apa Whatukura - *Māori male angels*, are the male children of Io-matua-kore, *the supreme being*, and act as Kaitiaki on the Amo that represents Ira Tāne (the male lineage).



### Kaitiaki o Te Mauri Atua

Māori pedogodgy dictates that all things have a Mauri - *lifeforce*, and that everything as such has a Kaitaki/guardian of that Mauri.

The Atua - *Gods*, assign Kaitiaki to protect the Mauri descending from the heavens

# Hine-ahu-one

Hine-ahu-one was the first woman created by Tāne and the Apa Whatukura from the kōkōwai (sacred red clay) at Kurawaka where Ranginui, the Sky Father and Papatuānuku, the Earth Mother were seperated.

Their blood mixed with the red ochre clay at Kurawaka and made it tapu (sacred) and there Tāne created the first woman & Whare Tangata (conception & birthplace of mankind)
