

Election Signage Bylaw – Ōrākei Ward and Tāmaki general electorate

This request is in regard to the bylaw for election signs in the Ōrākei ward and Tāmaki general electorate. https://at.govt.nz/about-us/bylaws/election-signs-bylaw/

A recent change has seen the time period for display of election signs on parks and reserves in Ōrākei reduced to four weeks prior to election day (all other wards/electorates are 9 weeks).

"Anyone putting up an election sign must be aware that most Local Boards have now limited their landowner approval for installing election signs on their local parks to the 9-week period before an election. (The Orakei Local Board only allows a 4-week period before an election for election signs on local parks and reserves in their area). Putting up an election sign on a public site in a local park outside that time frame is not authorised by the Local Board and the sign could be removed as an unlawful encroachment."

- When was this decision made and by which party(s)?
- On what basis was the decision in Ōrākei made? Please provide any briefing papers, minutes, requests for public submissions, and copies of submissions.
- When will this bylaw be formally reviewed?
- Will it be in force for the 2020 general election?
- What procedure should I follow to appeal the bylaw in Ōrākei?
- Any other information or advice that would be helpful to reviewing and appealing this bylaw decision as it relates to Ōrākei/Tāmaki.

The <u>Election Signs Bylaw</u> is a bylaw made by Auckland Transport.

Signs may be erected on private property or on designated sites that are public places. There are two types of designated sites: road reserve and parks. Auckland Transport approves the designated sites for road reserves. Parks are under the control of local boards. Clause 6 (3) in the bylaw states:

- "(3) Prior to specifying a site as suitable for the display of election signs Auckland Transport
- (a) obtain approval for any site located within a local park from the local board allocated responsibility for that local park; and
- (b) take into consideration any comments made by a local board responsible for the area on any proposed site that is not in a local park."

The Orakei Local Board resolved on 16 November 2017:

That the Ōrākei Local Board:

- a) amends landowner approvals for election signs to provide a four week time restriction on local parks and reserves in the Ōrākei Local Board area as identified in the List of Election Sign Sites.
- b) requests Auckland Transport's Traffic Control Committee to provide a four week time restriction for election signs on road reserves to provide a consistency for public sites across Auckland.
- c) requests Auckland Transport's Traffic Control Committee to consider updating its List of Election Sign Sites to reflect these time restrictions in accordance with clause 6 of the Election Signs Bylaw 2013.
- d) formally requests speaking rights at the next Auckland Transport Traffic Control Committee meeting and at the next Auckland Transport Board meeting.
- e) requests that the above resolutions be forwarded to all local boards for their information.
