    Use the <u>Unitary Plan (GIS) viewer</u> to find out if your tree is <u>notable</u> or in a SEA (meaning the tree has an additional level of protection).
  - 1.2 Tree or vegetation near a body of water

Trees or vegetation (non-pest species) are likely to be protected if:

- on or near (within 20m) steep coastal cliffs if the cliff is within 150m of the high tide mark
- on or near (within 20m) stream and river banks
- within or close to sensitive coastal or wetland areas. Tree protected by a condition on a past resource consent

Order a property file to find out if a tree is protected under a condition of a previously granted resource consent.

  Order a Record of Title from the LINZ to find out if a tree is protected under a
  consent notice or a covenant on the property title.
