There, let my salutations be borne across the isthmus to the Pūkaki lagoon and the community of Mangere. Paddling the Manukau Harbour we follow the Awhitu Peninsula to the headland. From there we fly down coast to the Waikato river mouth, sacred waters of our forebears. Coming ashore on the northern side at Maioro we head inland to Waiuku and Matukutūreia, there are the Pā - Tāhuna and Reretewhioi. Heading southward I come to Pukekohe. My words turn to follow the ancient ridgelines along the Southern boundary, dropping down into Mercer and Te Pou o Mangatāwhiri. My greetings reach you at Kaiaua who gazes across Tīkapa Moana to the sacred mountain, Moehau. Taking to the sea, my remarks travel to Maraetai and then to Ōhuiarangi, sentinel to Pakuranga. There we follow again the Tāmaki River to Te Puke o Taramainuku, Ōtara resides there. From here I reach for Manurewa until my greetings come to rest on Pukekiwiriki

below which lies Papakura

and there I shall rest.

Given the significant population growth in the wider board area, we continued to provide free community events to bring the community together, including Movies in the Park, ParkFest, Santa Parade, Carols in the Park, and a summer concert.

The completion of the extensive maintenance at the Hawkins Theatre has been pleasing. This included the installation of new air conditioning units, auditorium lighting and carpet upgrades.

We were delighted to see the progress of the climate resilience work going on in Papakura which fosters a connected, prepared, and resilient community through education, engagement, and resources.

We were thrilled about the recently opened new concrete pathway at Ōpaheke Passive Park and the immediate high usage by families. We also look forward to the continued work on the water and wastewater connection to the town main supply at Opaheke Sports Park.

We invested in two key pieces of work in 2024/2025. One identifies economic development opportunities and the other identifies sport and recreation facility needs. We are excited about the upcoming work relating to these projects and opportunities identified from these pieces of work.

The environment continues to be an area of importance to the community, and we will continue improvements to the Te Koiwi Reserve and Bruce Pulman Park stormwater ponds which will improve the quality of the water in the receiving environment. Environmental education in schools and the Papakura Stream restoration are well supported by the community, and we will continue to support them both.

We would like to thank the community for your contributions to our plans and projects.

The board looks forward to continuing to work together, building a strong future for the Papakura Local Board area.

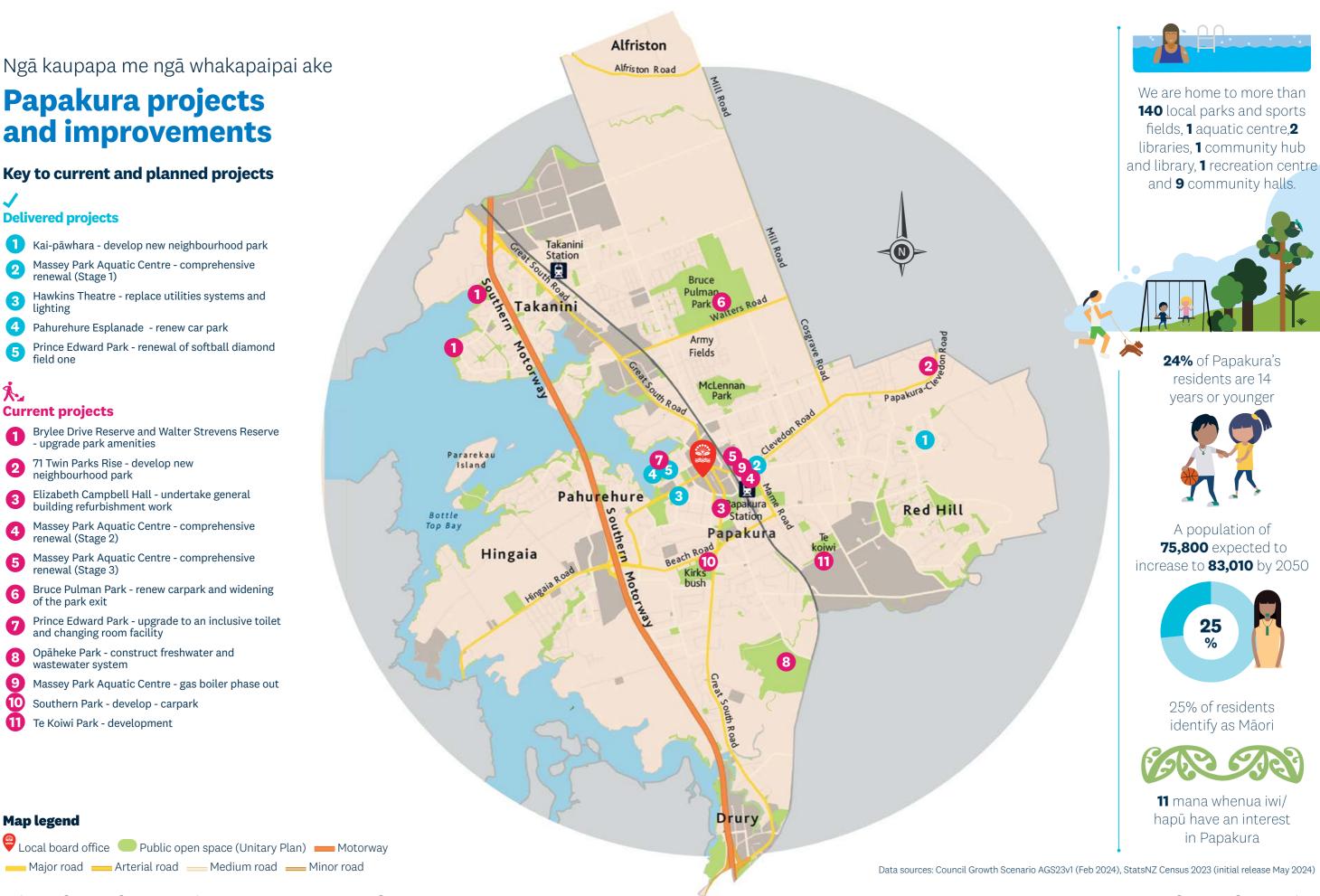

We funded local arts, culture, events, sport and recreation activities, and grants to deliver community outcomes and services. We continued to build and strengthen relationships between the local board and Māori communities. We delivered key initiatives including ANZAC services, mara kai community gardens, contributions to our local bands, and increased service levels at Papakura Museum.

Visits met targets for the first two quarters but exceeded targets for the last two quarters by 39 per cent. This performance was in line with the regional trend. Number of visits to Pool and Leisure Centres

Visitor numbers were slightly under target. OSCAR enrolment (Before and After School Care and Holiday Programmes) at Papakura Leisure Centre decreased significantly this year, and fitness membership numbers fell. The most common membership cancellation reasons cited were financial difficulties and/or leaving the area. Attendance at Massey Park Pool slowed, poor weather as a key contributor to lower numbers.

This approach allows us to plant more trees within the same budget. The overall budget doesn't change; rather, we find ways to optimise costs and achieve higher planting numbers.

Local environmental management

Our activities contributed towards a treasured environment and heritage. We funded a range of environmental initiatives which included school partnerships through the Wai Care education programme. Enhancing Te Koiwi Pond is an important ecological task which supports a partnership approach to regenerating the park and the pond. We supported healthy ecosystems and sustainability through local board-funded initiatives such as pest control, stream and water quality enhancements and waste minimisation projects.

Local flavour

Recording the Roots

For more than 30 years, a quiet transformation has taken place at Kirks Bush in Papakura. Once known as a place to avoid, this pocket of native forest has slowly become a sanctuary thanks to the tireless efforts of volunteer group Friends of Kirks Bush.

Now through the Kirks Bush Oral History project, those decades of dedication are being formally recognised, recorded, and preserved.

Led by historian Janine Irvine, and funded by Papakura Local Board, the project aims to capture and protect the stories for those who have played a role in reclaiming and restoring Kirks Bush.

The oral histories are more than a record of volunteer labour; they're a testament to community resilience and long-term commitment. From those who have spent countless hours pulling weeds, removing graffiti, advocating for improvements and kauri protection, this project is a chance to have their experiences formally acknowledged and archived for future generations.

In The Oral History of Kirks Bush, Muriel Nacey describes how rewarding it was to see people become more confident about walking in the Bush as conditions improved.

For Margaret Gane, Kirks Bush offered her a kind of pause or reset from daily life.

"They speak to me about something far bigger than me," she describes, recalling the feeling of walking beneath the tall tree canopy.

"I come out and my life is so much more in perspective. Those trees have lived through things I have not seen."

The survival of Kirks Bush amid Auckland's urban sprawl is rare, and its transformation into a place of safety, learning, and connection is thanks to those who cared enough to act.

The Oral History of Kirks Bush ensures that this care is not forgotten. It recognises the decades of quiet mahi and honours those who made a longterm commitment to the land.

Variance explanation Actual 2024/2025 to Annual Plan 2024/2025

1. We spent less than planned on repairs and maintenance because fewer costs from the City Care full facilities maintenance contract were allocated to local assets this year. The underspend also reflects delays in the improved maintenance programme for Pukekiwiriki Paa.

However, this underspend was partially offset by higher spending on us extending short-term contracts for some pools and leisure centres to keep services running smoothly. This was necessary while waiting for a decision on how these facilities will be managed in the future and to allow time for new contracts to be finalised. Facilities affected are Massey Park Aquatic Centre and the Papakura Leisure Centre.

- 2. We spent less than expected on capital projects and payments to staff and suppliers, which left us with extra funds. Because of this, we didn't need to borrow as much as originally planned.
- 3. Capital spending was lower than planned mainly because the development of the Kai-Pāwhara (formerly known as Kirikiri Reserve) was slightly delayed. Wet weather affected the remedial work on the concrete paths.
