Subject: Plan Modification: Clause 20A error correction to Auckland Unitary Plan (Operative in

Part 2016) or Hauraki Gulf Islands District Plan (Operative 2018)

I seek your approval to correct an error pursuant to clause 20A, schedule 1, Resource Management Act 1991:

A local authority may amend, without using the process in this schedule, an operative policy statement or plan to correct any minor errors.

You have delegated authority, as a tier four manager, to make a decision to correct an error under clause 20A. Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

Nature of error	The Stockade Hill Viewshaft Overlay text is annotated with 'rcp' which		
	indicates it is a regional coastal plan provision. The overlay applies only to a mapped area which is entirely over land. The provisions cannot apply in the coastal marine area and so cannot be regional coastal plan provisions.		
	The D20A.1 Overlay Description notes that the overlay is "used to restrict building heights to ensure that new development is of a height that does not intrude into or obstruct views to the coastal environment". The coastal environment includes the coastal marine area and adjacent land. The overlay protects views from Stockade Hill towards the coastal environment, and does not apply in the coastal marine area.		
	The overlay text in D20A.2 and D20A.3 provides a cross reference to D16 Local Public Views Overlay objective and policies which are regional coastal plan provisions. That overlay only applies as a regional coastal plan where the relevant viewshaft extends over the coastal marine area.		
	The mapped area of the D20A overlay is the area in purple below. The closest coastal marine area is 700m to the northeast.		





The note above the D20A activity table states that the table specifies the activity status of development activities in the Stockade Hill Viewshaft Overlay pursuant to section 9(3) of the Resource Management Act 1991. This means they are district plan rules only.

The GIS map for the overlay is not marked as [RCP].

Effect of change

The proposed correction:

- is to correct a minor error and
- is neutral (it would not affect the rights of some members of the public).

The maps and the note above the rules make it very clear that the overlay applies on land as a district plan provision. It cannot be interpreted as applying in the coastal marine area and so the removal of 'rcp' cannot affect any activity or requirement.

Changes required to be made (text and/or intext diagrams)

In the AUP, where there is no annotation, the objectives and policies are a district plan provision (AUP section A1.4). This means that both the 'rcp' and 'dp' should be removed from D20A.

Amend the headings in Chapter D20A as follows:

D20A.2. Objectives [rcp/dp]

(1)Objective D16.2.(1) applies to this overlay.

D20A.3. Policies [rcp/dp]

Policies D16.3.(1), D16.3.(2) and D16.3.(3) apply to this overlay.




D20A.6.1 Height

Purpose: to manage the height of buildings to:

- maintain the visual integrity of the view by minimising the visual intrusion of buildings
- protect views to the coastal environment from public open spaces, including scheduled historic heritage place
- (1) In applying these standards, height must be measured using the average ground level method.
- (2) Buildings within the Stockade Hill Viewshaft must not exceed a maximum building height of 8m within the areas as shown on Figure D20A.6.1.1

- (1) buildings and structures that intrude into the viewshaft:


