- · You will receive a tag once you have completed the application process and we have received your payment.

#### Important privacy information

Your information is required under the Act to register your dog(s). Failure to provide the requested information will result in your dog not being registered, which is an offence under the Act. Section 35 of the Act allows any person to apply in writing for the name and address of the owner of any specified dog. Auckland Council is required to provide that information where it is satisfied of that person's identity and that the information is required for one of a limited number of purposes specified in section 35(5), such as returning a lost dog to its owner or seeking compensation for damage.

The personal information that you provide in this form will be held and protected by Auckland Council in accordance with our privacy policy (available at <u>aucklandcouncil.govt.nz/privacy</u> and at Auckland Council libraries and service centres) and with the Privacy Act 2020.
