<p>Papakura Local Board event - 16 March</p> <p>Sports are funded well. Arts are the poor cousin. Thanked local board for their support. Paul gave an overview of the activities associated with the Papakura Theatre Company and band. Have a good relationship with the other bands and the Hawkins Theatre. A privilege to be able to entertain people. Have a diverse membership and ages. Community theatre has been around for 68 years. Have won more best plays than other societies in Auckland. Have a strong membership. People keep coming back. They come from all over Auckland to participate which brings audiences in from all over Auckland. Have a strong core group that build the sets. Spoke to their forward planning. Would love to train the youngsters on the technical side of things but don't have the capacity to do that. Would welcome any support or ideas around that. The music rights rates are costly. 2021 was challenging with Covid lockdown. Have moved shows around. Have four shows this year and the big band and a summer festival planned for 2022. Technology is moving quickly - it's an evolving space, costly and challenging to keep up.</p> <p>Who owns the building? The bulding is owned by the Pulman Trust. It leased to the Theatre Company. They pay the lease and he then refunds everything except the GST. Bruce Pulman is now the patron. The Theatre Company pays a very favourable \$9,000 lease per year for a commercial property in Wood Street that houses the costumes made over the years. Sublease one half of the building. Also The Theatre company also pays the outgoings on the buildings.</p> <p>One part of the Theatre at the back of the building the company would like to expand the theatre to get use of. Storage is always a premium in a theatre.</p>	1
<p>Lives on Settlement Road just up from the Opaheke Road intersection. Lives across the road from the cemetery. Traffic volumes have increased expotentially.
