Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

- Pausing our change to the split between business and residential rates. Under our current policy, annual increases to general rates for business properties are less than for non-business (residential and farm/lifestyle) properties, so that over time the share of general rates paid by business properties is fairer. Our proposal is to put this change on hold for one year

Debt

This will be used to fund some capital expenditure (assets such as roads, pipes and buildings) that is currently planned to be funded by operating revenue (such as rates and user charges). This will free up that operating revenue to help address our budget shortfall.

Auckland is the economic hub of NZ, we should not be cutting such significant funding for programmes of activity that generate economic return to not only Auckland but New Zealand. Tourism pre COVID was NZ's largest export industry, Auckland is the largest destination. By not enabling funding of tourism and promotion of Auckland, other destinations domestically and globally will take such economic benefit from our region into their own, the flow on effect into retail and hospitality, employment in industry would be significant. We will lose major events, business events, attracting overseas skilled workers in tech industries, overseas investment in large economic projects, all of which generate economic benefit to the region. Therefore cutting budget in this area that enables and generates direct and indirect economic benefits to the region, a region that has suffered significantly more than any other region in NZ from covid does not make sense.

As a career consultant I have been aware of the work of COMET since my time in working for Career Services rapuara from 2001-2010. COMET with the support of Auckland Council funding has advocated strongly for the voice of young people to be heard when it comes to the implementation of educational and employment strategies in the region. As a result close to 5000 young people have transitioned into work through the COMET youth transition programme over the past decade. Furthermore, I attended the YEA conference (Uniting for Change) last year and I was most impressed by the content presented at the conference.

In justifying the ongoing funding of COMET one only has to look at the current National NEET (not in Employment or Education) figures. In three years from 2019 -2022 NEET figures have increased from 10.3 per cent in June 2019 to 12.1 per cent in June 2022 (Labour Market Statistics - NZ Statistics), resulting in an actual increase of 17.5 per cent.

The proposed reduction may mean a small cost to those who use the public services but it is affordable. I highly doubt the effectiveness and efficiency of those community programs. I suggest we cut them off and re-setup them with careful audit. Firstly we need to address homelessness problem and other basic needs; then for those art and culture things. People will find their activities even if the council don't provide it to them. I suggest increasing charges for council facilities. For example the swimming pools and libraries, the charge is too small to cover cost. I also suggest council cancel the inorganic rubbish collection service. The company which runs this service had been very bad. I would like to opt out of it and get deduction on my rate. Using the money on some commercial rubbish collection company will get much better service. For example I get 3 cubic meter bag collection service for \$150 while council only give me 1 cubic meter and the service was very bad -- they require booking at the beginning of the year; they don't come on the booked date, rubbish was left in garden for long time; they sometimes don't come at all, you need to re-book; there are lots of limitation on what they accept. And after all you can't opt out of the bad service. If council canceling this service, a lot of management work can be saved. At least this service should be outsourced to commercial companies where there is competition.

Auckland Council Budget 2023 - Submission

1) About Volunteering Auckland

Purpose:

Volunteering Auckland is the lead support organisation for volunteering across Tāmaki Makaurau Auckland. We promote and support volunteering to ensure a positive experience for volunteers and non-profit volunteer-involving organisations and projects.

Activities/Services:

Our services include the recruitment and referral of individuals and teams of people interested in contributing to their communities through volunteering; learning development and networking opportunities for those responsible for volunteers in non-profit community organisations and projects; research and development projects focused on supporting volunteers and volunteering; and promoting volunteering through a range of media.

Who we work with:

Volunteering Auckland is a leader in the network of Leaders of Volunteer Engagement in Tāmaki Makaurau Auckland as the only organisation who promotes and supports volunteering.

We have over 200 community organisations [not just members of VA] access and gain support from our services. We also work with private, public and community partners in the employee volunteering space.

We also work alongside any organisation who supports and encourages volunteering e.g. Auckland Council, its local boards and various departments, and regional organisations such as Conservation volunteers.

2) Preamble to Volunteering Auckland's submission

- a) Local Government has a statutory obligation under the Local Government Act 2002 to promote social, economic, environmental and cultural wellbeing of communities. Council's budget proposal threatens this obligation and Auckland Council would be left with the promotion of economic development, severely falling short of its legislative obligations.
- b) This budget proposal targets "operational" savings and service cuts; "easy" targets because the budgets for these programmes are set on an annual basis, and are funded largely by local board's Locally Driven Initiatives (LDI) budgets - contrasting with capital projects that are included in the longer-term budgets. The outcomes of LDI-funded activity are often also longer-term, and less immediately visible or tangible than is the case with investment in capital infrastructure.
- c) The proposed cut of \$41 million to funding for LDI, community services and regional contestable grants represent an overall budget cut of 2.55% but will have a disproportionate and enormous impact on communities, community groups, regional coordinating/support bodies such as Volunteering Auckland, the volunteering workforce, the wellbeing, safety and trust of Auckland's peoples, and

the general social infrastructure and fabric of Auckland. The societal ramifications will potentially be for years to come.

3) What makes our communities vibrant, sustainable, and liveable? What makes our communities cohesive, inclusive, peaceful and safe?

- a) Communities are what make our kiwi way of life. We are all involved with our communities at some level, whether through local community halls and libraries, sports groups, hobby clubs, conservation groups, service organisations, safety/Maori/Pacific wardens, community gardens, local community hubs, playgroups, arts and cultural events or festivals, or a myriad of groups that run programmes that support our health, wellbeing, social connectedness, life-skills learning etc.
- b) Altogether Auckland's community organisations constitute the social fabric of our society, and the proposed cuts to community resourcing and support in the proposed Auckland Council budget will potentially be severe and negatively impact on social cohesion, sense of community safety and trust; incidence of gravity and crime; isolation, vulnerability and mental health of our communities; maintenance of our parks, waterways and our built environment.
- c) These outcomes of cuts to Council's currently funded community programmes will not always be immediately apparent. However, rectifying such issues will be problematic and costly, depending on their scale. Once community organisations disappear or lose their capacity and credibility, it can be extremely difficult to resurrect them.
- d) With such societal challenges and without strong diverse supportive community organisations, Auckland will potentially become less popular as a destination for newcomers and more residents may make choices to move elsewhere from Auckland.

4) What makes people feel they belong and are part of the community?

- a) For members of every sector of society, no matter their socio-economic status, age, capabilities, faith or ethnicity, community groups play an essential role in helping them to be able to participate and feel part of their community.
- b) Community groups, and their volunteers, make things happen such as events, programmes, informal learning opportunities; these groups support connections between individuals who are lonely, isolated, inactive, between people of diverse backgrounds, and between different elements within a community. Local and regional groups can provide support, information, advice and the opportunity to participate in activities. Without these benefits created by community organisations, communities and society generally are at risk of becoming fractured, disconnected, disengaged, distrustful and dissatisfied.

- b) So often it is the collective effort of community groups and their activities that make people, neighbours and community members come together, collaborate, support one another, feel less helpless, feel valued and of worth. We have witnessed this with the floods and Cyclone Gabrielle where communities had to act immediately to respond to their crises, but were also hugely supported by their local and other community groups which will become even more important through the recovery process. What made the difference for those affected between feeling abandoned and desperate and being able to carry on in the face of disaster was the visible, practical, collective efforts of local communities and groups, often volunteers, coming together. The majority of rescue and recovery activities were organised through existing volunteer-reliant community groups.
- c) It has often been seen to be preferable to maintain and build capital infrastructure, because the results are immediate and tangible. And yes, community centres make it possible for groups to come together, connect, and develop but it is usually community groups that activate the centres through their programmes, connections with communities, dedication to the needs of their community members, and flexibility.
- d) The many positive social, environmental and cultural benefits that come about through active and effective community groups take time and resourcing to achieve. By reducing the capacity of groups to operate (whether social, recreational, environmental, cultural, sporting), this leads to a weakening of the social infrastructure of communities which then impacts negatively on social cohesion, people's sense of safety, trust and belonging with the resulting effects of increased crime, interpersonal and inter-community hostility, fear loneliness, stress, mental health issues, which can be both immediate and longer-term impacts. Dealing with these negative outcomes is costly, complex, time-consuming, and long-term.

5) What do we know about the reliance on volunteering in New Zealand/Auckland?

a) NZ Volunteering statistics

- In a 2022 quarterly report, Stats NZ reported that approximately 21.5% of New Zealanders undertake volunteer work with an average 234,618 Kiwis volunteering each week.
- More women volunteered than men, with 53.7% of women volunteering over the previous four weeks, compared with 47.5% of men.
- Of those who have volunteered, 30.2% volunteered through an organisation and 36% volunteered directly (i.e. undertook informal volunteering).
- According to JB Were's 2021 report, 9 in 10 organisations rely solely on a volunteer workforce to contribute to their mahi and organisational outcomes.

b) Impact of Covid-19

Local and national surveys of the NGO sector found that volunteer-reliant organisations were experiencing a significant dropping-away of their older

volunteers, due to concerns about COVID, other health constraints and/or family commitments.

c) Current concerns for our volunteer-reliant community organisations

- A major concern is that the increase in the cost of living and other financial challenges may well result in people currently in the labour force needing to prioritise paid work and greater income over volunteering.
- Labour market figures already indicate that older people are already continuing to choose to work longer, and many retirees are returning to paid work due to financial pressures.
- There is often an expectation that it will be women who will be expected and needed for providing voluntary services to support our community organisations, on top of informal volunteering, parenting, and paid work.
- With respect to the proposed cuts in Council's draft budget, what needs to be strongly guarded against is the assumption that volunteers will fill Council's dollar gaps, doing work that council once paid for, but now will not. This is unacceptable in terms of employment law, and equally critically in terms of the increased pressure on Auckland's communities and organisations.

d) Implications for volunteer-reliant community organisations

- With these trends and with community organisations already very reliant on volunteers, there is little lee-way for them to easily find additional volunteers, and they may end up competing for volunteers. To address these gaps, more funding and targeted campaigns would be necessary to promote the need for more volunteers from all sectors of society.
- More than ever, community groups will need strong volunteering infrastructure, meaning effective processes for recruiting, training, supervising, supporting and retaining their volunteers, following relevant legislation and good practice guidelines. Such infrastructure requires funding to be sustainable.
- It is the role of Volunteering Auckland to support community organisations to have effective and sustainable volunteering infrastructure, and in particular to support and train their Leaders of Volunteer Engagement to carry out good practice volunteer management. This includes not just community organisations but also large employers (such as Auckland Council) that require volunteers for many of their activities, and businesses that have volunteering programmes for their staff.

6) Other impacts of proposed cuts to Auckland's volunteer-reliant community sector

- a) It is well-established via research and experience that volunteering plays a crucial role in underpinning social inclusion, civic participation, wellbeing, safety. Volunteerism also contributes to and enables place-based, ground-up solutions and resources to address a wide range of social needs. "Volunteering is interconnected with civic engagement and participation and can contribute to social cohesion. Volunteers are essential to building community capacity and enhancing community resilience and wellbeing." (From Volunteering NZ)
- b) Many community groups operate on very small amounts of funds and may not survive without council support. Once that support is cut, some groups will go

under immediately while others will need to reduce their services, cut staff, including those responsible for the volunteer programmes and will not have the capacity to support volunteers. “Alternative” funding sources are already oversubscribed and may not sustain additional requests for support.

- c) If community groups are struggling to exist and become even more reliant on involving volunteers, it is highly likely that they will struggle to provide adequate support for their volunteers. Volunteers can be taken advantage of, when organisations are under pressure to survive and the organisations may pay less heed to ethical, fair and law-abiding good practice volunteer management. As stated previously, a strong volunteering infrastructure is crucial for community groups to effectively recruit, utilise and retain volunteers.
- d) Volunteering infrastructure has a cost and many community groups may choose to reduce or cut funding that they spend on their volunteering programmes eg. do away with positions that oversight their volunteer programmes, volunteer training opportunities, or reimbursement of expenses [creating a barrier to people being able to contribute to their communities].
- e) Volunteering Auckland foresees that it will be increasingly in demand and of even greater value in supporting community groups to engage with volunteers, treating them appropriately and ethically, and in enabling them to have suitable structures, processes and personnel to coordinate their volunteers, and to support and retain them.

7) **Auckland Council’s Thriving Communities Strategy**

This is a critical strategy for Auckland Council, widely consulted on to ensure it has relevance for all communities. It has as its key priorities:

- manaakitanga - the essentials of a good life, with the ability to fulfil their potential
- whanaungatanga - connectedness to other people and a feeling of belonging
- kotahitanga - participation in our community, while taking action to meet common goals
- kaitiakitanga - connectedness to the natural environment.

Volunteering Auckland recognises the vital importance of the following objectives for community empowerment. These all require Council funding and support to be successfully achieved, and for Council to stay true to its Thriving Communities strategy.

- increasing access and participation so more Aucklanders can access and take part in the things they care about
- growing community and intercultural connection so all Aucklanders feel as though they belong
- enabling local leadership and innovation so we can harness the power and creativity of community
- increasing community resilience and sustainability so Aucklanders can make the best use of the resources available to them, whilst reducing emissions.

8) Alternatives / potential solutions to proposed cuts to community services

Putting 'local' at the heart of the Thriving Communities priorities and objectives is crucial to ensuring that Auckland's communities continue to thrive.

Three actions that Council can take to continue to support 'local for local', and stay true to the principles of Thriving Communities are:

1. Work with Volunteering Auckland to build the 'local' capacity of community to engage volunteers, to ensure that volunteers and the voluntary sector are not subjected to additional risks or bad practices, and to bring more corporates and businesses on board to support community groups and their projects, through employee volunteering.
2. Recognise the important role of Council's local community brokers - who provide the glue in Council/community partnerships - and ensure they have ongoing and secure funding from an appropriate council budget, not from the very vulnerable local board LDI budgets.
3. Properly record volunteer labour within Council and ensure it is accounted for, reported on and therefore valued. There is a well-known principle in business that your greatest asset is your people. In the same way that we value and support paid staff, we should value and support the unpaid contribution of volunteers - who do so much for Tāmaki Makaurau Auckland.

Submission: Do not proceed with reducing funding to Tātaki Auckland Unlimited (TAU) as it affects the operating budget of the Auckland Art Gallery Toi o Tāmaki. Do not proceed with reduced opening hours or introduction of entry charges at the Auckland Art Gallery Toi o Tāmaki.

A public art gallery is crucial to the social and political wellbeing of a city, and to the capacity of individuals within it to thrive. Art makes a difference in people's lives. Specifically, the Auckland Art Gallery Toi o Tāmaki provides transformational experiences to a diverse audience and should be publicly resourced to continue doing so.

Cuts proposed to the Gallery's operating budget leaves it with an operating budget of \$9.5m pa, after shared TAU services fees are deducted. This is compared to \$32.2m and \$18.6m that Auckland Museum and MOTAT received in full respectively in 2022-2023. This imbalance between the city's major cultural institutions leads to a great loss for the city: loss of visitors, loss of access to and care of the contemporary taonga commissioned and held by the gallery, and loss of artists and others livelihoods, which are in turn integral to sustaining cultural practices and wellbeing in Aotearoa. And, unbelievably, TAU is expected to propose even more cuts.

The people who work for Auckland Art Gallery Toi o Tāmaki are qualified to do a job that matters, and that they believe in: upholding the role of art in our everyday lives. Their knowledge and experience cannot be replaced. Highly skilled in developing exhibitions, public programmes, research, building and maintaining archives, and as kaitiaki of both visitors and of the collection, they provide education and points of access for all who visit the gallery. Close to 500,000 people are projected to visit the Gallery in 2023. (MOTAT, 2022: 100,554 visits, Museum, 2022: 488,553 visits.)

Entry charges do not work. Data from independent researchers demonstrate that the introduction of entry charges to the Gallery in 2018/19 caused significant harm – around 30% less visitors, 60% less people joining guided tours and losses for the Gallery's other income revenue sources, the shop and the café.

I advocate for Council's recognition and support of Auckland Art Gallery Toi o Tāmaki's work. A well-resourced public gallery is an essential organ within a city's wholeness, and can generate much-needed change for our future. The Gallery plays a primary role in enabling Auckland Council to achieve its goals for wellbeing – social, cultural, environmental and economic – and as such, must be considered foundational within a flourishing city.

Public transport is a vitally important tool to help us fulfil our responsibility to reduce greenhouse gas emissions and slow down climate change; it has important public benefits in allowing members of the public who cannot drive or cannot afford a private vehicle to move around the city; and it reduces congestion which has huge costs in terms of productivity. Public transport investment and use is a chicken and egg scenario: that faster (ie bus lanes) more reliable, cleaner, and more efficient the services are, the more they will be used. I strongly disagree with the argument that if people are choosing to use private vehicles there is no need for public transport and these services can be cut. Rather, this is reason to fund these services more.

Secondly, I strongly disagree with the proposed cuts to arts, cultural, and social welfare programmes in the city. This case study goes back a little while to our lockdowns, we had a father with children under 5 who approached us, he was without a job at this time, financially stressed, and said he cried a lot because of his situation. Initially we listened and then we helped him decide on the help he needed, then we actioned. He had financial mentor support plus additionally he worked with a supported employment practitioner to help him find another job. For employment he got a temporary contract first, and then fulltime paid employment. He also had mental health support to get him through this situation safely. He was back on track and in a good mental space when he got his permanent job a little further down the track.

The following is not a case study but fact: A distant relation of one of our team was going in a very similar situation, a Dad, with children of a similar age, and in bad financial shape due to having lost his job. He did not reach out to CAB, the family hushed up his situation. In the end he was facing bankruptcy and attempted to take his own life.

There is a stark and sad difference between these two situations. Here at CAB we save lives through our daily interactions and keep families together. People come to us because they trust us. We are part of their community, part of the glue that holds it together.

We show people they do have a path to walk, and point out the different directions they can take as they walk along that path.

At CAB Glenfield our volunteers collective experience is 200 years between them when you add up the years they each have served as Volunteer Bureau Interviewers in our branch. We have 30 volunteers, 3 of our volunteers are law students who are volunteering to help with their degree – we provide a place where they can do this, 10 volunteers with a second or even third language. As well as New Zealand's official languages Maori and English, we also have volunteers who speak Mandarin, Tagalog, Bisaya, Samoan, and Hindi. We value our diversity, our wisdom, and so do your communities, the people of our city.

- Reducing regional services such as community and education programmes, regional events, economic development, and other social services activities such as homelessness funding, community empowerment and funding for youth centres to save \$22 million
- Reducing local board funded activities across all boards to save \$16 million
- Reducing regional grants to save \$6 million
- No longer directly providing early childhood education services to save \$1 million.

2. Amending Auckland International Airport Limited (AIAL) Shareholding Policy

Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

What is your preference on this proposal to change the AIAL shareholding policy to enable the sale of all Auckland Council's shares? Enable a partial sale of our shares, maintaining a 10 per cent shareholding in AIAL (reducing our interest costs by around \$40 million per year), and further increase rates and/or debt

Tell us why:

3. Managing rates and debt

To help with our budget challenge, we propose a total rates increase for the average value residential property of around **4.66 per cent or \$154 a year** (around \$3 a week) and to increase our use of debt by up to **\$75 million** in 2023/2024.

Rates

Our proposed 4.66 per cent total rates increase would be achieved by:

- An average increase in general rates of 7.0 per cent across all existing properties, including non-residential
- Reducing the Natural Environment Targeted Rate (NETR) and Water Quality Targeted Rate (WQTR) by around two thirds and using the money we have already collected from these targeted rates to continue delivering these work programmes as planned in 2023/2024
- Pausing our change to the split between business and residential rates. Under our current policy, annual increases to general rates for business properties are less than for non-business (residential and farm/lifestyle) properties, so that over time the share of general rates paid by business properties is fairer. Our proposal is to put this change on hold for one year

Debt

We propose to increase our use of debt by up to \$75 million for 2023/2024. This will be used to fund some capital expenditure (assets such as roads, pipes and buildings) that is currently planned to be funded by operating revenue (such as rates and user charges). This will free up that operating revenue to help address our budget shortfall.

What is your preference on our proposal to manage rates and debt? Proceed with the proposed increases to rates (4.66 per cent overall for the average value residential property) and debt (up to \$75 million of additional debt)

Tell us why:

4. Storm Response

The impacts of the recent storm events beginning on Auckland Anniversary weekend could be substantial over time and we don't yet know the full costs.

Changes to our investment in land, infrastructure, buildings and equipment will be needed. Some new investments will be delayed so we can undertake urgent repairs and replacements.

Additionally, from 2023/2024, we are proposing to increase our operating budgets by around \$20 million each year to improve our ability to prepare for and respond to future storms. This would likely require rates to increase for 2023/2024 by around an additional 1 per cent (on top of the 4.66 per cent increase proposed to address our budget shortfall).

What is your preference on our proposal to manage the impact of future storms? Do not proceed with the proposal

5. Local Boards

Devonport-Takapuna Local Board

It is proposed to reduce funding by \$16 million across all local boards which will impact the activities and services delivered by local boards. Given this possible reduction in funding, **what do you think of our proposed priorities for services and activities in this local board in 2023/2024?** I do not support most priorities
