Our proposal to save \$130 million would also require us to make other reductions, including:

- Maintaining the currently reduced number of public transport services (as of December 2022) for 2023/2024 to save \$21 million
- Reducing our funding to Tataki Auckland Unlimited to save \$17.5m, with some effects on service delivery and pricing at venues it manages such as Auckland Zoo, Auckland Art Gallery, and stadiums and venues in Auckland
- Reducing regional services such as community and education programmes, regional events, economic development, and other social services activities such as homelessness funding, community empowerment and funding for youth centres to save \$22 million
- Reducing local board funded activities across all boards to save \$16 million
- Reducing regional grants to save \$6 million
- No longer directly providing early childhood education services to save \$1 million.

What is your preference on the proposed operating cost reductions?

Do not proceed with any reductions and instead further increase rates and/or debt

Tell us why, and which reductions you would <u>not</u> proceed with if any: These are all important things. Covid has thrown out all figures, so give the city time to get back up to speed by borrowing in the interim until we have a much clearer idea of what the real income and shortfalls are.

2. Amending Auckland International Airport Limited (AIAL) Shareholding Policy

Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

What is your preference on this proposal to change the AIAL shareholding policy to enable the sale of all Auckland Council's shares? Don't change the policy, keep all our shares and further increase rates and/or debt

Tell us why: This is so shortsighted and again based on Covid earnings. Let traffic increase back to normal levels and income will rise. It is important that we keep a substantial stake in this critical route in and out of the city and the country. You can't trust bus

3. Managing rates and debt

To help with our budget challenge, we propose a total rates increase for the average value residential property of around **4.66 per cent or \$154 a year** (around \$3 a week) and to increase our use of debt by up to **\$75 million** in 2023/2024.

Rates

Our proposed 4.66 per cent total rates increase would be achieved by:

- An average increase in general rates of 7.0 per cent across all existing properties, including non-residential
- Reducing the Natural Environment Targeted Rate (NETR) and Water Quality Targeted Rate (WQTR) by around two thirds and using the money we have already collected from these targeted rates to continue delivering these work programmes as planned in 2023/2024
- Pausing our change to the split between business and residential rates. Under our current policy, annual increases to general rates for business properties are less than for non-business (residential and farm/lifestyle) properties, so that over time the share of general rates paid by business properties is fairer. Our proposal is to put this change on hold for one year

Debt

We propose to increase our use of debt by up to \$75 million for 2023/2024. This will be used to fund some capital expenditure (assets such as roads, pipes and buildings) that is currently planned to be funded by operating revenue (such as rates and user charges). This will free up that operating revenue to help address our budget shortfall.

What is your preference on our proposal to manage rates and debt? Other

Tell us why: Increase both rates (by 4.66%) and increase debt. Once Auckland has recovered from Covid, we should be able to reduce that debt. The NETR and WQTR should not be reduced - these are important.

4. Storm Response

The impacts of the recent storm events beginning on Auckland Anniversary weekend could be substantial over time and we don't yet know the full costs.

Changes to our investment in land, infrastructure, buildings and equipment will be needed. Some new investments will be delayed so we can undertake urgent repairs and replacements.

Additionally, from 2023/2024, we are proposing to increase our operating budgets by around \$20 million each year to improve our ability to prepare for and respond to future storms. This would likely require rates to increase for 2023/2024 by around an additional 1 per cent (on top of the 4.66 per cent increase proposed to address our budget shortfall).

Highbury Community House Submission

Highbury Community House Incorporated (Highbury House) is located in Hinemoa Street, Birkenhead. We provide community support, connection and engagement for the community of Birkenhead and its neighbours in the wider Kaipātiki area.

Auckland Council Annual Budget

We do not support a reduction in funding for Local Boards.

Local Board Members are representatives elected by the community to be our local-level voice, a role that we feel is crucial to community wellbeing.

We urge Council to explore options for increasing efficiency and focus in its operations ahead of reducing Local Board funding.

Kaipātiki Local Board Priorities

We acknowledge that the Board is likely to be faced with the significant challenge of funding reductions.

In this context, we suggest that the Local Board review and rationalise the services offered by groups it funds, in both the **community and environmental management** space. It appears there are areas of overlap in what groups offer, and that efficiencies could be achieved, if there were clearer roles and defined outcome-based accountabilities.

We believe there is scope for many of these local groups to become more efficient and/or self-sustaining. To that end, we would value an opportunity to sit around the table with the Local Board (and others as/if appropriate) to discuss and explore how we might jointly achieve better outcomes for Kaipātiki.

Our submission below presents our case for the retention of funding to Highbury Community House.

Provision of community services – community delivery and programmes

Our request

We request that the Kaipātiki Local Board allocate funding for Highbury House as a high priority.

We acknowledge that the Board is facing a challenge of significant funding reductions and ask that any reduction in funding for Highbury House is as minimal as possible.

Why continue to support us?

There are two key reasons why funding for Highbury House should be a priority:

1. We deliver clear, proven community outcomes. While Birkenhead is our primary focus, the positive impact of the services we offer means our reach extends beyond Birkenhead to the wider Kaipātiki area.

2. The funding will support us while we further assess and implement strategic initiatives that will enable Highbury House to continue delivering value sustainably, e.g., more of a social enterprise model.

These two points are expanded on and explained below. We also provide supporting data as evidence of our impacts.

The valuable community outcomes we deliver

While Highbury House is located on Birkenhead Point, this does not mean that we focus purely on that local neighbourhood. We have very high levels of engagement and participation from the wider Birkenhead community, as well as from other areas of Kaipātiki such as Beach Haven, Glenfield and Northcote.

We deliver value and impact our community in the following ways:

- Creating connection in an environment that feels safe.
- Stimulating learning, exploration, personal growth, and exploration of new ideas.
- Ensuring we cater for and support all age groups, including young and old.
- Providing an opportunity for people with diverse perspectives to find common ground.
- Creating an environment of fun and celebration in, of and for the community.

The above provide significant community benefits and outcomes, including:

- People feel a sense of connection and belonging authentic community.
- People know that people at Highbury House care, and will support them.
- A greater sense of community wellness and ownership.
- Increased appreciation of diverse groups within our community.
- Reduction in mental health issues arising from isolation.
- Older community members keep their brains active and stimulated.
- Young people gain insight into what it means to be a community and productive members of society.
- Awareness (and comfort) for people knowing there is a safe place to go.

By way of example and to provide substantiating evidence about the breadth and depth of our engagement, we have summarised some recent data below.

Use of the facility in 2022

It will benefit all Aucklanders if they live in a city where people have access to spaces where they can learn and engage in the community, even if they personally do not use them. As Auckland becomes more dense and private dwellings become smaller, community spaces like libraries will become even more important. Nobody wants to live in a city with poor services. Personally I was living in Wellington when the main central library was closed and found this do be a massive loss.

I also do not agree with the proposal to cut funding for Citizens Advice Bureau. The reality is that not everyone, in fact, unfortunately, a majority of people, cannot afford to get legal advice from a lawyer. Particularly when they are not even sure whether they have any legal rights in the first place. The Citizens Advice Bureau is a staple of the community and

such a "base-level" service for any city. Proposing to cut its funding sends a message that the Council does not care about its residents.

The Birkenhead Residents Association (BRA) is proud to represent the community of Birkenhead, in the Kaipatiki Local Board area. BRA represents approximately 1600 households of Birkenhead Point and surrounding environs.

We recommend that Council undertake a review of all its departments with a view to improving efficiency and reducing the overhead of resources who are not delivering core services above. We note that Council's headcount has increased significantly, doubling in the last 11 years and would like to see it reduced to become more efficient and outcome focused.

In undertaking such a review, Council should also engage with local communities to ensure there is no overlap or unnecessary expenditure. For example, we are aware of Council funds being used to pay someone for a service that the Local Community volunteers already deliver; this is clearly wasteful and not good use of rates funds.

1. Operating spending reductions

Auckland Council have already decided to reduce costs by simplifying management structures and sharing resources more across the Council group (including Auckland Transport and other Council Controlled Organisations).

Our proposal to save \$130 million would also require us to make other reductions, including:

- Maintaining the currently reduced number of public transport services (as of December 2022) for 2023/2024 to save \$21 million
- Reducing our funding to Tataki Auckland Unlimited to save \$17.5m, with some effects on service delivery and pricing at venues it manages such as Auckland Zoo, Auckland Art Gallery, and stadiums and venues in Auckland
- Reducing regional services such as community and education programmes, regional events, economic development, and other social services activities such as homelessness funding, community empowerment and funding for youth centres to save \$22 million
- Reducing local board funded activities across all boards to save \$16 million
- Reducing regional grants to save \$6 million
- No longer directly providing early childhood education services to save \$1 million.

2. Amending Auckland International Airport Limited (AIAL) Shareholding Policy

Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

3. Managing rates and debt

To help with our budget challenge, we propose a total rates increase for the average value residential property of around **4.66 per cent or \$154 a year** (around \$3 a week) and to increase our use of debt by up to **\$75 million** in 2023/2024.

Rates

Our proposed 4.66 per cent total rates increase would be achieved by:

- An average increase in general rates of 7.0 per cent across all existing properties, including non-residential
- Reducing the Natural Environment Targeted Rate (NETR) and Water Quality Targeted Rate (WQTR) by around two thirds and using the money we have already collected from these targeted rates to continue delivering these work programmes as planned in 2023/2024
- Pausing our change to the split between business and residential rates. Under our current policy, annual increases to general rates for business properties are less than for non-business (residential and farm/lifestyle) properties, so that over time the share of general rates paid by business properties is fairer. Our proposal is to put this change on hold for one year

Debt

We propose to increase our use of debt by up to \$75 million for 2023/2024. This will be used to fund some capital expenditure (assets such as roads, pipes and buildings) that is currently planned to be funded by operating revenue (such as rates and user charges). This will free up that operating revenue to help address our budget shortfall.

4. Storm Response

The impacts of the recent storm events beginning on Auckland Anniversary weekend could be substantial over time and we don't yet know the full costs.

Changes to our investment in land, infrastructure, buildings and equipment will be needed. Some new investments will be delayed so we can undertake urgent repairs and replacements.

Additionally, from 2023/2024, we are proposing to increase our operating budgets by around \$20 million each year to improve our ability to prepare for and respond to future storms. This would likely require rates to increase for 2023/2024 by around an additional 1 per cent (on top of the 4.66 per cent increase proposed to address our budget shortfall).
