2. Amending Auckland International Airport Limited (AIAL) Shareholding Policy

Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

Netball Manurewa has a young membership. We are conscious our community is finding it difficult in these times of high inflation. Our membership struggle to find the money to participate in sports. However, for the greater good and the benefit to the wider community, Netball Manurewa supports increasing rates to:

The carpark was completed in 2014. This is a wonderful addition. Before the carpark was built we would have at least one pedestrian hit by a car when crossing Dalgety Drive each year. The carpark now limits the number of people having to cross the road. It is also an asset for those hiring the facility.

All the courts have been dug up, relayed with asphalt and appropriate drainage installed. Water no longer sits on the courts.

Courts 5 – 12 were upgraded prior to the 2015 netball season. Courts 2-4 were upgraded post the 2015 season. There are now three courts in the court 1-4 location. Court 1 has become a warmup area. The long-term plan for this area is for a playground to be installed. Courts 5-8 also have futsal markings.

Courts 2-4 have dual court markings with netball, tennis and turbo touch. During the summer months tennis nets are located on these courts which are well utilised by the public during the summer period.

Basketball courts are located between courts 2-4 and 5-12. Every day young people utilise the basketball courts. It is great to see the community utilising the facility regularly on a casual basis.

MANUREWA BUSINESS ASSOCIATION SUBMISSION TO AUCKLAND COUNCIL ANNUAL BUDGET 2023/2024

28 March 2023

Introduction

The Manurewa Business Association (MBA) is the local business association acting on behalf of the Manurewa area. The MBA is a Business Improvement District (BID) and two years ago successfully expanded to include the Clendon Business community as part of the BID in Manurewa. The MBA represents approximately 500 of our business community across Manurewa and Clendon Town Centres.

Our objective is to ensure that Manurewa and Clendon Town Centres are known as vibrant, safe, accessible and connected places that will attract, grow and retain business to drive employment and economic stability in the area. A key role of the Manurewa Business Association is the partnership with the Auckland Council, the Manurewa Local Board and other local authorities to bring about improvements for the betterment of the Manurewa and Clendon Town Centres by lobbying for the interest of local businesses and community. Furthermore, our partnership with our Local Board and the Governing Body enables investment, activations, Town Centre vibrancy and provides valuable input into the future development and of Manurewa for all our communities.

There are currently 50 BIDs in Auckland, with a combined capital value estimated at \$72.7 billion.

Our role in the Auckland economy is to improve the business environment of our areas, promote innovation, prosperity and employment as well as attract new businesses, customers and visitors.

We share this common goal with the Auckland Council group of promoting Auckland's economic prosperity. The Council group play a pivotal role in providing efficient and effective core services for the city. Auckland must continually strive to attract more visitors, and bid competitively to host major events, as well as support economic development activities.

The marketing of "Auckland Inc" firmly sits within the scope of council's core services - no other entity has the resources, nor the single minded focus, to position our brand internationally. Council must continue investing in this important service to support economic development.

Turning to the key themes identified in your Consultation Document, we want to speak about:

(1)Managing ongoing budget pressures(2)Managing rates and debt(3)The Storm response

(4) Changes to other rates and fees and charges, and

- (5) Other matters important to us
- (6) Local Board Submissions

(1) Managing ongoing budget pressures

We acknowledge that Auckland Council is facing significant budget challenges with a forecast budget shortfall of \$295 million and now also a huge cost blow-out of \$1 billion for the City Rail Link.

First, we absolutely support Auckland Council holding "tough" talks with the Government to push it to pay more for the City Rail Link. This is a fundamental piece of national infrastructure, a national asset and should always have been fully or mainly funded by Government. Hundreds of millions could be clawed back here by Council.

In terms of the need for efficiencies and savings, we ask that the detailed review of services across the Auckland Council group be progressed more quickly. We believe there should be a sharp focus on finding savings from the management of contractors and consultants by the Auckland Council group, as we still experience evidence of wastage.

The world has been in a Covid crisis and recovery mode for the past three years. A deficit would be expected given the loss of Council revenues over this period. The data shows additional borrowing is well within the debt ceiling and that Council has got stable and AA credit rating.

We also support additional and prudent borrowing even if it requires more than \$75 million of additional debt.

We do not support selling any, some or all or of Council's shareholding in AIAL.

As we expressed earlier, we do not support the \$27.5 million funding reductions proposed for Tātaki Auckland Unlimited. Instead, we ask that the budget for marketing Auckland internationally, attracting visitors, bidding for and hosting major events as well as supporting economic development activities be maintained. We also ask that the budget for local board funded events, local economic development and Town Centre re-generation be maintained. These activities are what makes Auckland a 'vibrant' place in which to live. A harsh austerity budget will be detrimental to the city's recovery from three years of COVID-19 disruptions.

(2) Managing rates and debt

Turning to managing rates, we appreciate that this is important in terms of Council's budget challenge.

However, we do not support pausing the long-term differential strategy.



The intention of the long-term differential strategy is for the share of general rates paid by business properties to be made fairer. However, every time there is a budget challenge, Auckland Council pauses the longterm differential strategy. We are strongly of the view that this is unacceptable.

We do, however, support an increase in general rates no higher than inflation.

We understand that you do need to identify solutions for meeting costs. We would support a general rates increase of 7.0 per cent or less of an increase.

If the Natural Environment Targeted Rate and the Water Quality Targeted Rate is reduced by the proposed amount of around two thirds, then support using the money Council has already collected from these targeted rates to continue delivering these work programmes. This should be included in the future when the existing money has been spent as these are critical infrastructure projects.

(3) The Storm response

We agree that the impacts of the recent storm events over Auckland Anniversary weekend and Cyclone Gabrielle have been substantial for Council.

They have also been very serious for many businesses, and many of our business associations have been witness to this devastation.

We have been concerned about the lack of ownership regarding the risks from flooding and all the silos that operate within the Council group, which certainly came to the fore during and following the flooding events.

We find it incredulous that core functions, such as keeping the drains free from blockages or maintaining storm water pipes, fall between several agencies, and sometimes into some kind of void between Auckland Council and Auckland Transport or Waka Kotahi. We understand that the maintenance schedule was reduced to only once annually during 2020, and we all now know that this is hopelessly inadequate, and shortsighted.

This needs your urgent attention. Keeping the drains free and regularly maintained is core business, and the schedule needs to at least double to twice annually.

We agree that the floods and slips mean that urgent repairs and replacements must be carried out ahead of less urgent work.

So, we absolutely agree with increasing operating budgets by around \$20 million to support the repairs and replacements as well as prepare for and respond to future storms and understand that this may raise rates by an additional 1%.

However, we think this funding should be 'ring fenced' for these purposes. We need to ensure money is collected for any future events as a form of insurance.

(4) Changes to other rates and fees and charges

We understand the staff challenges being experienced by Auckland Transport, but instead of maintaining the currently reduced number of public transport services, we ask that they be increased as more staff become available. Auckland needs quality, reliable public transport that brings people to Town Centres and other parts of regional Auckland. This must be prioritised.

(5) What else is important to us

We are concerned about the proposal to reduce open space maintenance by reducing 30 per cent of litter bins across the region. In our view, keeping our region, but especially our Town Centres tidy and free from litter, is core business.

We are also concerned about the reductions in garden maintenance for 80 per cent of gardens. Again, we don't want to see this result in the reduction of amenity of gardens in our Town Centres.

We are also concerned that Eke Panuku Development plans to reduce or withdraw from public realm projects and local events in Town Centres, such as Matariki festivals, weekend workshops for kids as well as Christmas and cultural New Year celebrations. Again, we are concerned that these reductions will reduce the amenity and enjoyment of our Town Centres.

We are especially concerned that if further cost reductions are required, Eke Panuku will exit from urban regeneration activities in up to 11 priority locations across the region. We fear this will impact heavily on the amenity of our Town Centres as private development will continue, but without regeneration of the public realm.

The MBA is also fully supportive of our Citizens Advice Bureau (CAB) continuing to receive the subsidy that Auckland Council provides them. The Manurewa CAB is a well utilised resource in our Town Centre and a valued part of our community. Research shows that for every \$1 invested in the CABs \$13 is received in services. This is excellent return on investment and helps make our community an equitable place for all members.



Of concern also are proposed reductions to homelessness funding. Manurewa was one of the leading centres in Auckland to drive a community led response to successfully managing homelessness in our area through the Housing First model. Homelessness is a complex issue requiring a multifaceted and cross agency support system. Town Centre businesses are often first responders to dealing with homelessness and it is essential that we continue to provide wrap around services to support homelessness initiatives throughout Tāmaki Makaurau.

The MBA is also fully supportive of our youth centres and work together with our rangatahi to support and empower them through leadership programmes that develop strong and resilient futures and help set career paths. We do not support the proposal to reduce of stop funding for youth centres and community education programmes.

(6) Manurewa Local Board Submissions

Many of the services that the Manurewa & Clendon Business Associations currently provide could be negatively impacted under the Manurewa Local Board proposed budget cuts. The key areas impacted are local economic initiatives, safety and placemaking, local activation, civic events, capacity building and strategic partnerships.

A few examples where the Business Association relies on funding support and programme stakeholder partnership through the Manurewa Local Board are:

CCTV Cameras

We currently operate 64 cameras in and around Manurewa and Clendon Town Centres. The Business Association provides staffing to access footage as and when needed by Police and other key agencies. Footage from our system is correlated with a reduction in volume crime and is a key tool in the safety and security of our Town Centres.

Ambassadors

The MBA employ a team of Town Centre Ambassadors to be the key points of contact with our local businesses. They are our eyes and ears on the ground and assist business and community with everyday queries. The Ambassador programme is supported by the Manurewa Local Board and ensures local jobs for local people building career pathways in Manurewa.

Manurewa Link Bus

The Manurewa Link bus is a free bus services linking Manurewa and Clendon Town Centres and their local neighbourhoods. The bus started in 2019 and has constantly grown in patronage, even through the covid lockdowns of the last couple of years. The Link Bus is a key connector between business and community and supports local businesses and the communities that they serve.

Placemaking activities

Placemaking and activation are essential drivers of safety and attractiveness in our Town Centres. Events and activities including the Santa Parade, Coffee with a Cop, Safer Plates and more bring people and customers to our Town Centres supporting our local businesses and encouraging our community to buy local.

Conclusions

As we enter another year where the resilience of small and medium sized businesses will be tested, we ask the Council to consider carefully their needs as it makes decisions about the priorities and proposed savings in the Annual Budget 2023/2024.

We ask that there be a focus on providing those services which grow the economy and support local businesses, especially in our Town Centres.

We fundamentally believe greater savings can be made with a culture of efficiency being instilled across the council group. Now is the time for the council, and it's significant number of employees, to adopt a rate-payer mindset. But council must not lose sight of Auckland's ongoing economic prosperity.

Our priorities include support for Eke Panuku to invest in Manurewa and Clendon Town Centre development, retention of CABs in Auckland and continued investment in public transport in the Auckland region.

We support safety, local transport, placemaking, youth and homelessness initiatives and see these areas as investments into the future of both business and community wellbeing. We believe in providing and growing civic and community led events and support local and regional funding for these to continue.

We also believe in the strength of Auckland Council doing the basics well, so storm response is critical for a functioning society.
