2. Amending Auckland International Airport Limited (AIAL) Shareholding Policy

Our proposed budget includes a planned change to the AIAL shareholding policy. This will allow us to sell some or all our shares in AIAL.

Selling all our shareholding (currently around 18% of shares in Auckland Airport) would reduce our debt by an estimated \$1.9 billion. This would reduce interest costs on our debt by around \$88 million per year, which is greater than what we'd expect to earn from the dividends if we kept the shares.

We have also considered other options, including both keeping all our shares and a partial sale that reduces our shareholding while maintaining at least 10 per cent (a so-called "blocking stake"). These options would contribute less towards our budget reduction target and require other actions – most likely by further increasing rates or debt (within existing policy limits).

What is your preference on this proposal to change the AIAL shareholding policy to enable the sale of all Auckland Council's shares? Don't change the policy, keep all our shares and further increase rates and/or debt

Tell us why: There is no benefit to ratepayers if the shares are sold and it is used to reduce debt only. The shares were gifted to the people of Tamaki Makarau and should be held as security for the future. They will only increase in value going forward, and in the fu

To help with our budget challenge, we propose a total rates increase for the average value residential property of around **4.66 per cent or \$154 a year** (around \$3 a week) and to increase our use of debt by up to **\$75 million** in 2023/2024.

Rates

Our proposed 4.66 per cent total rates increase would be achieved by:

- An average increase in general rates of 7.0 per cent across all existing properties, including non-residential
- Reducing the Natural Environment Targeted Rate (NETR) and Water Quality Targeted Rate (WQTR) by around two thirds and using the money we have already collected from these targeted rates to continue delivering these work programmes as planned in 2023/2024
- Pausing our change to the split between business and residential rates. Under our current policy, annual increases to general rates for business properties are less than for non-business (residential and farm/lifestyle) properties, so that over time the share of general rates paid by business properties is fairer. Our proposal is to put this change on hold for one year

Debt

We propose to increase our use of debt by up to \$75 million for 2023/2024. This will be used to fund some capital expenditure (assets such as roads, pipes and buildings) that is currently planned to be funded by operating revenue (such as rates and user charges). This will free up that operating revenue to help address our budget shortfall.

This budget shows very little understanding of the way in which local communities have developed in spite of the lamentable way in which the Auckland Council has done a very poor job of spending the money it has raised from rates payments paid over many years by its citizens.

“The shady adventures” of Fiscal Hole as reported in the Gulf News on 16 March 2023, gives a very informative editorial and I quote: “Fiscal Hole appeared and is now centre stage in a public consultation (that lasts until Tuesday 28 March) in a breezy “have your say” exercise.” (Copy attached).

While this is supposed to be a consultation process, judging by past experience of such consultations, this process will only answer the questions the council wants to ask and will fail to understand the communities it is supposed to serve. Nothing can be achieved by asking a few questions that are put in such a way that a statistical analysis could never give a definite answer. But what do you expect when different communities have different needs and wants and the members of those communities have different needs and wants.

Having spent 50 years living in an island community my voluntary work should have concluded as a community development spokesperson a number of years ago. My interest and investment in this community started in the 1970's when I joined the local sports club through my interest in playing rugby football which developed into coaching and committee positions.

I progressed through the Waiheke Golf Club to Grey Power, WI Community Planning Group, the then WI Council of Social Services and Direction Matiatia.

One thing has remained constant throughout all this is that no Reserves Management Plan has been finalised. On November 22 2022, as a result of my written submission of 8 November, I made a presentation to a hearing by the Waiheke Board detailing the sorry saga of the inability of the council and its predecessor to comply with the Reserves Management Act. While I was verbally thanked for my "presentation", four months later, nothing in writing. So forty years have gone by and there is still no management plan for our parks and reserves and we are left waiting for yet another report from council officers.

I mention this as an example not only of the incompetence of council staff but also of their complete disregard of members of the community who may have been "listened" to but have not been "heard". Just the same as the public forum at local board meetings, thank you and request yet another report from the officers. The local board wants us to "tell council what matters" but expects people to go to them. When are they going to come and talk to us ? What can we expect of a mayor who has not even bothered to step foot on our island, used our unreliable ferry service or helicoptered in to one of 62 landing places ?

Through my community development interests, I am aware of the many and varied needs and wants of members of the community. I have absolutely no interest in Art nor have I visited the Auckland Art Gallery or the local gallery and there are those who have not been to a sports stadium or local sports club. Yet members of both groups both have a valuable contribution to make to their communities.

One thing we do have in common is the Hauraki Gulf, once described by a former mayor as "the jewel in Auckland's crown". Alas, after many reports, this is no longer so and it is about time that all interested parties got together and get something done locally rather than wait for the inevitability of climate change. The Environment Commissioner's recent report on the loss of up to 30% Green Space since 1980 could well be applied to the Hauraki Gulf. (NZ Herald 16 03 2023)

So just how is the council going to make equitable cuts to each community when it should not rely on the statistically compromised results of this consultation or the "human rights" of those who pay rates.

Volunteers are now few and far between thanks to all the rules and regulations instigated by government and local government.

Even as I bring this feedback to a conclusion we are informed in today's NZ Herald front page that the mayor "is threatening to unleash regulatory powers against private landowners who fail to clear streams of obstructions as he launches an emergency recovery plan to help rebuild the city following January's devastating floods." I trust that he will unleash the same regulatory powers on the council itself "at the council's lack of stream maintenance". A local spokesman summed it all up: "No amount of stream maintenance would have prevented the flooding on 27 January, there would still have been places that flooded".

Start by caring for the people, not blaming them.

The shady adventures of Fiscal Hole

All last week, the trailer for a *Fair Go* television episode asked, incredulously, how someone could just lose a million dollars.

Three days later, I'm writing this editorial and wondering how Auckland Council, an operation with a guaranteed revenue stream of \$5,676 million and 11,000 employees has managed to spawn the villain of this tale, Fiscal Hole, all \$295 million of him and still growing.

I will probably never get used to Auckland Council's presentation of what were once careful and important public consultations documents now turning up looking like books for preschoolers: silly stock figures in bright primary colours and words in that slightly over-loud and repetitious tone that some people use to talk to very young children - or inferiors.

In September last year, Fiscal Hole's very existence was dismissed as a bogey to frighten children. Council's performance figures were right and tight, balanced to the last dollar.

Over the intervening months - with the council's share of the enormous rail link budget blowout still undisclosed - Fiscal Hole appeared and is now centre stage in a public consultation (that lasts until Tuesday 28 March) in a breezy "have your say" exercise.

He's on every page, a cautionary tale telling us, the stakeholders, to choose whether we want to relinquish our remaining legacy asset airport shares, or our libraries, zoo, parks, arts, community grants, swimming pools and discretionary funding for local boards.

Rates or asset sales? More may happen closer to year's end in June, officials say, sounding a bit weaselly about the council's own share of frugalities. Wait and see how old Fiscal works out before then, eh?

The new mayor and holder of this poisoned chalice says it's a structural problem 12 years in the making (which puts the blame squarely on the Key government's second and quite iniquitous supercity restructuring).

The breezy feel is an illusion we ignore in the submission process at our peril. If we, the punters, aren't very definite on the issue, the bureaucracy has a mandate to carry on this rake's progress that includes massive contracts to offshore contractors and the sort of opacity and favouritism with the big boys that got us into the mess in the first place.

\$1.8 billion dollars of airport shares, or part of it, would paper over some of the debt but the city visibly haemorrhages money, usually on the things that officials want rather than citizens need. They shouldn't see this process as a mandate to carry on as before.

In the way of politicians and adminis-

trators, the optics on the airport shares are fairly one-dimensional. The council says the shares do not make a cent.

It's that old simple lie beating complicated truths. As researcher Kushlan Sugathapala said in a *NZ Herald* column last week, council's stake tripled from \$632 million to \$1.8 billion from 2011 to 2018, a capital gain of \$1.2 billion in seven years. And \$485 million in dividends and a share buyback - a profit of \$1.7 billion in eight years from 2011 to 2019.

Cost saving would average just \$24 million per year until 2027 and less after that, he said. "We deserve better. It's like selling an investment which has tripled in value in eight years to pay off debt, ignoring any potential gain. Shouldn't we have better protection against trigger-happy politicians and government officials from selling our family silver?"

The council's website copy of the draft budget plan for Aucklanders taking part in the submission process outlines a huge divestment of services, while the all-or-nothing questions are really quite dishonest.

On Waiheke, we will share the pain of a 16 percent cut in discretionary funding to the city's local boards, standing to lose operating funding of \$382,493.

Waiheke's funding impact statement in council's annual report to 30 June last year showed a \$878,000 reduction in debt for capital funding on the year's budget. Payments to staff and suppliers and capital expenditure were lower than planned and the year's allotted \$2.3 million capital spending budget remained unspent.

Another million saved to ransom our villain, Fiscal Hole? Or is it really necessary anyway? \$295 million is derisory in the scale of council expenditure and its management's self indulgent annual expansions.

Reduced local library hours, cutting back mowing for open spaces and funding for events, community grants, community climate action, environmental education, water quality and waste minimisation grants are also on the block.

They shouldn't even be considered. If the council doesn't want to provide the traditional and most basic services people need for their rating dollars, it shouldn't increase rates at all.

And the airport shares are family silver and shouldn't even be considered at this early stage of trimming the fat either. Fiscal Hole is there to reprise profligate, kleptocratic Thatcherite political management and we should not stand for it. • Liz Waters

I am the current manager of the Te Huruhi Community Pool and I am a committee member of the Waiheke Pool Society.

I wanted to email my support to maintain the current funding from the Waiheke Local Council to the community efforts to create a new in-door pool on our island.

- * Pool user numbers are up in years past and continue to grow.
- * The amount of children learning to swim on Waiheke have grown and would continue to grow if we could secure year-round lessons (in a covered pool facility)
- * Instructors would be more highly involved and continue to grow their own experience and training with the ability to teach year-round in full-time employment.
- * Lane swimming is so sought after, however currently we are restricted to the time slots we have available due to the full schedule and limited daylight hours and staff available.
- * Lifeguards would be more reliable as they would be able to rely on their role and income year-round with an in-door facility.
- * The elderly could use an in-door pool for their own fitness
- * All our current scheduled classes could operate year round with confirmed time slots year-round; Aqua Fit, Adult Technique Classes, Swimming lessons for both children and adults, Lane Swimming, Surf Lifesaving training + in-school swimming programs, and private pool hire for birthdays/ events.
- * We have a number of classes we would want to add if we have a deeper facility such as water polo (we currently offer Flippaball for childrens years 3-6 which is an introduction to Waterpolo however we do not have a facility currently to offer water polo. Hello,

I'd like to make a submission on the annual plan process, for the retention of funds set aside by the Waiheke Local Board for an indoor community swimming pool.

We have lived on Waiheke since 2009. Lobbying (and fundraising) for a community pool was well underway and had been going for some years before that. Since then, year after year, we've been asked to keep submitting, fundraising and supporting the local pool society, which works tirelessly and without thanks.

Now, my children are 11, 9 and 6. They are some of the lucky few who have benefitted from private swimming lessons in the city year after year. We have prioritised this for their own safety, living on an island and in the early days at least, without the option of local swimming lessons. The cost of this has been well into the thousands of dollars, including ferry costs. Unfortunately, the majority of children on Waiheke miss out on this privilege, other than a few lessons they get through school over the summer terms now that the Te Hurihi Pool is heated.

Even for kids like my 11yo, who loves swimming, attempting to compete in any kind of inter school event highlights the huge gap between them and their peers in the city. Basic practice to dive 'off the blocks' for example, requires a trip to the city. We tell ourselves that we're proud of our Waiheke kids for 'giving it a go' and we tell them that it's largely about the experience and building resilience.

But it shouldn't have to be this way, when there is the will and intent to make a community pool happen, with a highly active society dedicated to the development of a replacement swimming pool. Other fundraising groups and sports teams could only dream of a group of parents and community members so passionate.

It is saddening to think the Local Board can't get behind this once and for all and it is to the detriment of our young people, who deserve to be prioritised.

Submission to Council regarding the Proposed Budget

Waiheke Island

I wish to express my strong objection to Auckland Council's proposed funding cuts for essential cultural, social and environmental services within the community. I do so for the following reasons.

The financial analysis used by council is faulty and presents only one possible scenario of the scale of debt and the ways of dealing with it; that of selling off assets (of increasing value such as the airport shares) and cutting important and varied social and cultural services. Better Budget (referred to below) offers alternative analysis.

Council responsibilities go beyond the material aspects of living within a particular geographical area, the basic and limited 'Bricks and Mortar' issues. They also take in those aspects which meet social needs and which foster and support a sense of community well-being .These include shared and valued community facilities such as parks and reserves, art galleries, museums, libraries and information centres such as Citizens Advice Bureau.

Community social cohesion arises from the reflection of that community in all its diversity and needs to reflect geographic, economic, social and spiritual aspects: social and cultural concerns, qualities and experience. A sense of community cohesion and pride fosters a sense of identity and pride and caring for that community. If the Council doesn't care and value these facilities, why should the individual members .

The cuts proposed relate to a wide range of aspects of Council responsibility and ways to service or deal with Council debt. Basically, the chosen methods represent a divestment of services. Targets are wide and varied but all are of essential social and cultural importance. Some of these include cutting grants to libraries, zoos, art galleries, museums, swimming pools and other community facilities and increasing rentals for facilities on Council owned properties (thus decreasing their already limited running costs.) The notion that these facilities are dispensible or can be staffed by reduced workforce or volunteer labour is a nonsense; these facilities are as much a part of the Council's brief as the community's buildings and businesses. Their budget proposals, as noted, represent a "gutting the soul of the city." (GN editorial 23 March 2023)

Also proposed is reducing discretionary funding for local boards, which suggests that Council intends to pay no attention to regional differences or to particular qualities and features of local boards and locations. This ignores regional, geographic, cultural and socio-economic differences between suburbs and regions and bespeaks a 'one size fits all' mentality. However, clearly , as an island community with a diverse population, Waiheke is very different from other Auckland suburbs. As well, proportionately, the proposed discretionary funding cut of 16% is not in line (per capita) with the population bases of other communities, nor does it recognize the increased stress on facilities of tourists and visitors, over 60,000 per year.

Council supports community wellbeing in many and various ways and should continue to do so. This support, both physical and spiritual, generally comes from well organised and accessible institutions. It involves careful, responsible and sensitive planning to create, maintain and care for adequate and attractive environments, (both living and recreational) access to places and institutions which provide, for example, help in wellbeing and health and recreational, artistic or

legal support. Such institutions include Citizens Advice Bureau, Budgeting and Financial support, Art Galleries, museums, libraries, parks etc.

A quick glance through Waiheke's Gulf News confirms the importance of these institutions and their role in community well-being, musical and artistic expression, as well as knowledge and learning. Such places form a backbone to our community and allow people access to gather and share knowledge or artistic and musical experience, in short to be active and involved members of 'a community.' The Council has responsibility to support (by funding) the successful functioning of facilities and pursuits which underpin a sense of community.

Of particular concern in this day and age are those activities and facilities pertaining to environmental responsibility and climate change: community climate actions and environmental education, water quality, waste minimisation, to name but a few of those significant areas potentially affected. Now, more than ever, we need to give these primary consideration so that society may better cope with increasingly inevitable consequences of (previous and present) irresponsible environmental behaviour.

For the mayor and councillors to focus only on rates, buildings and other tangible, physical structures and concerns, indicates a shallow (narrow) interpretation by Council of its responsibilities and presents these in simplistic and inaccurate terms. This narrow frame of reference (of responsibility, problems and possible solutions presented in Council proposals) does not pay due consideration to assets, values and debt ratio to fully represent options open to them in dealing with real debt and debt reduction. Other possible options are outlined in Gulf News Editorials on 16 and 23 March 2023 and in the analysis of 'betterbudget.org.nz'.

The proposed budgetary cuts involve and impact on so many of these providers of social and environmental wellbeing. Cuts in budget and increased rental for council owned property also means that each of these providers struggles to maintain financial viability. It has been suggested that in some areas, funding shortfall can be taken up by a shift from professional to volunteer labour. However, reduced council support in their operational funding would cause increased unfair reliance on the already stretched volunteer labour force.

Apart from unapologetically shifting responsibility for these Council roles to private individuals, it is cynical and disingenuous to assume that volunteers have limitless resources (money, time, energy etc.) so that they can take on more. Those with an active social and environmental sense of responsibility are often those busiest in our society. They are aware of the enormous needs, limitations (of funding) etc. inherent in areas in our society and already contribute vast amounts of time and money to ensure our society and environment function well and that facilities and activities are widely available to all, regardless of individual socio-economic background.

As well, calling on increased volunteer participation (for example in libraries) is an insult to the well trained professional librarians, the depth of their knowledge and responsibility and the multiple tasks they perform, implying that they merely issue books, stamp them in and out. Equally, proposals of reduced hours for our libraries underestimates and reduces options for a diverse range of people in our community; commuters for example are already constrained by accommodating into their daily timetables the requirements of family, ferry and work. With reduced hours their options would further decrease.

Proposed cuts and changes impact on provision of a wide range of aids to cultural and social and personal health, such as access to the legal knowledge and facilities offered by Citizens Advice Bureau. Reduction of funding of these services is likely to impact those most in need, for example the poorest (and perhaps less literate) members of our society who do not have the means or

perhaps knowledge to explore other legal avenues. CAD performs an essential service in ensuring access for all to needed legal knowledge and services, particularly those with less confidence seeking information and social support. Again, it is dependant on the goodwill and skills of volunteers who already give service and who should not be expected to give more because of changed Council priorities, policies and constraints. Council needs to maintain their role in supporting these important facilities.

Divestment of services also presupposes outsourcing massive contracts to offshore contractors which has historically been demonstrated to ultimately be more expensive and less satisfactory in outcome than using local contractors. It is a cost glossed over in presenting Council's recent budget proposals,

Council has been guilty of not recognizing the value all of these facilities bring to the city and its people and of not sharing the responsibility for continued viable maintenance of them by adequate funding. These community facilities are not just “nice extras” but also an integral part of those features that represent the well-being of acommunity. They are popular and well used and deserve continued maintenance and adequate financial input by Auckland Council.

Revised budgetary proposals should represent more faithfully the value these facilities bring to the community.
