Dear Mayor Brown

I wish to tell you how disappointed I am about the unfair new rates, after doing everything to help with making our nature better and following the Council's lead (*ref Waste Nothing*).

You may wonder what this means... Well, let me tell you what I did, and why I am so upset about the rates for rubbish and food scraps removal.

1. I use my Bokashi bin (**previously provided and encouraged by your own Council**) to compost my veges, and dig it into my garden.

Result: I do not have to put out the little food scraps bin, and my soil is getting better every day, and my veges, the soil creatures and nature like it too.

2. I am a single woman, living in a smallish unit, and I recycle (**as instructed by your own Council?**) all the recyclables from my household that are allowed.

Result: Single persons have way less recycling, so I only put out my recycling bin once in three months.

3. As a single person, all I have to put in my 40 litre wheelie bin are the plastics, a few other items and previously recyclables that are now not being recycled any more.

Result: I push out my rubbish bin once in two months, costing me about \$3.50 per 2 months, coming to \$1.75 per month. The total cost over 12 months would come to \$21.00 before the rate hikes the Council now proposes.

Reaction: **How is it fair to now charge me \$145 per year, while I followed your lead and now I get punished as (a) a single person (b) a Gold card holder (c) as a single income person who at 70 is still working to pay off my home loan.**

MY SUGGESTION:

Give single households a much lower rate, if you have to let them pay for anything. What happens to our Rates & Taxes anyway?

OR

You can give single persons a no-charge rate, or at least a huge subsidy. **\$21 versus \$145** is a huge amount!

This is the reality that single persons and Gold Card holders in NZ have to face, and we are being ignored and extra costs just added to our bills.

If you have any decency and sympathy for single, working, older than 70 year

persons to survive in the current economic climate, then something needs to be done to correct this imbalance.

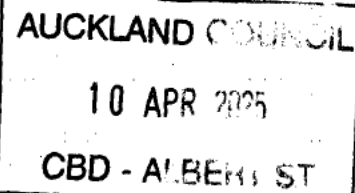

Hi folks,

As a manufacturer of New Zealand grown ingredients into NZ made food products we use a lot of expensive power. In our food category (sauces and pickles), 90% of the products on shelf in supermarkets and on menus in restaurants are produced overseas – by a foreign workforce with the help of affordable power.

We are one of the few in the industry that is manufacturing in NZ using a local Auckland workforce – using products grown in NZ and harvested by kiwis. Power pricing makes this extremely expensive to manufacture and as seen with a largely shutting down NZ production industry – very difficult to compete.

Power/electricity is the only input we buy that gets more expensive when you purchase more! When we scaled up our production into Mt Roskill last year we began paying a whole bunch of fixed fees each month just to have a connection (as well as the more familiar and variable based on usage “energy charges” like you would pay at home).

The line charge and metering fee which totals close to half of our monthly expense is where I see the biggest issue for power cost. They are fixed charges that we get each month regardless of power usage – mostly for the privilege of being able to receive power. It breaks down as follows:

However, Auckland has more to lose from Manufacturers closing as the biggest manufacturing region in the country so I think this is something that should be driven by Auckland council to remedy.

Help save manufacturing in Auckland and NZ! Power should be more affordable for industry than households...its non sensical.
