We have not set a regionwide policy framework for the Is there any provision to purchase small plots of land for boat provision of recreational boat ramps yet because of other launching? priorities. Hibiscus and Bays Local Board did look into ways to improve the provision of boat ramps in the area, for

example through improving car park layout, but opportunities are limited.

The Resilient Lands and Coasts Department advise that reclaiming land to build new ramps is not typically supported by the council. This is mostly because it is really difficult to get resource consent for this kind of activity, and even more so if it involves reclaiming land (creating new land by filling in or extending land over a body of water like the sea).

In addition, there are large costs involved in buying and developing new land with road access to the water in locations appropriate for a boat ramp.

Maintenance and renewal of the council's existing coastal assets, including boat ramps, is managed by the Parks and Community Facilities and Resilient Land and Coasts Departments. The Long-term Plan 2024-2034 allocates funds to pay for this service, based on areas with the highest needs.
