Climate Change: A big section of the Local Board Plan is on Climate Action and to us that means starting with makin sure our infrastructure is in good shape.

We need the Plan and Auckland Council to focus on these aspects of our infrastructure :

Please work with Auckland Council to fix the slips along the roads, footpaths and tracks.

We're already getting far more traffic and visitors because people can't go to Piha and Karekare and this will only increase come summer. We need the roads fixed and tracks reopened, but fixed properly once, rather than a quick fix that needs repairing again in a short time and costing us more.

Rather than reforesting rural land we would encourage you to make it an immediate priority to get slip areas replanted to reduce them slipping again or becoming infested with weeds.

We desperately need pot holes filled along Cornwallis and Huia Roads.

Storm drainage: Thanks for visiting Cornwallis and seeing for yourselves some of the problems we have. Council has done some things along the road but our problems haven't been fixed nor have the drains near the houses cleared. In fact in instances what Council contractors have done will only make things worse. Gillman can explain.

Footpaths: We still want a decent footpath. Advocacy is a section in the draft Plan. One area where we want to support you in advocacy is to get Auckland Transport to allocate more money to building basic footpaths communities like Cornwallis are asking for.

Parking for public transport: Cycling is never going to be a good option for the majority of residents out our way, but we could use public transport more from places like Titirangi, Glen Eden and New Lynn if there's adequate parking. Please

We support your efforts to get the Natural Environment Targeted Rate spent more quickly especially on getting tracks improved and reopened and full implementation of the regional pest management plan. If not, the rate should be reduced permanently.

As you know the big priorities for SCOW are continuing to make grant funding available for our pest control activities and funding effective weed control activities especially on public land along roads and that surround private properties. Gillman has more to say on that.

Manukau Harbour- we support your efforts on behalf of the Manukau Harbour and participating in the Manukau Harbour Forum. We support your focus on water quality and working with Watercare and Healthy Waters to reduce overflows into the-harbour. Council should be spending funds it's collecting from residents with wastewater systems on environmental programs in our area or not charge us. (Watercare is already thinking about re-permitting the Mangere Treatment Plant and we need the Local Board to be advocates for tightening the effluent standards for the plant and working with Watercare to find ways of reducing the volume of discharges into the harbour.)

The other big priority for us regarding the harbour ( and the shoreline adaptation planning) is making sure West Aucklanders continue to have access to the foreshore and water of the Manukau for recreation, boating and fishing. Cornwallis Beach is an extremely popular, family friendly beach for West Aucklanders. The grassy picnic areas adjacent to the beach need to be protected from managed retreat. If not, where are people going to sit and picnic and play? Similarly the foreshore of Little Huia must be protected for fishing, kayak and boat access, not to mention protecting the road out to Whatipu.

We appreciate all your hard work advocating for us and the West especially within Auckland Council. We wish you all the best as you implement the Plan.

# Q7. Our Community: Have we got it right, and what is your view on how these things are addressed in the plan? Q7. Tell us why Our Community – support proposals.
