Schedule 2A of the "Chief Executive's Delegations Register, March 2024, Version 1.3" authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

	Discussion			
	Transpower New Zealand Limited (Transpower) has recently completed works to dismantle a transmission line between Albany and Henderson (Albany-Henderson 110kV transmission line). Therefore, the corresponding National Grid Corridor Overlay that applies to this transmission line is no longer required.			
	Transpower has requested, in a letter dated 6 March 2024, that this section of the National Grid Corridor Overlay be uplifted from the AUP GIS maps in accordance with Chapter D.26 National Grid Corridor Overlay in the AUP (refer to Attachment 1).			
	Chapter D26.4 Activity Table, paragraph 7, requires an automatic update for removals of the National Grid Corridor Overlay [emphasis in bold added]:			



	The National Grid Corridor Overlay rules cease to have effect and the maps can be updated accordingly where:			
	a) <b>a National Grid line</b> or part of a line <b>is dismantled</b> , undergrounded or moved;			
	or			
	b) a National Grid substation is dismantled, or the site boundary of a National Grid substation reduces in size;			
	and the following has occurred:			
	c) <b>Transpower New Zealand Limited has advised the Council in writing</b> ; and			
	d) The council has advised owners of the property from which the overlay will be removed in writing;			
	That the National Grid Corridor Overlay provisions are no longer required for that line or part of that line, or for that substation or that part of that substation.			
	As required by c), Transpower has advised the Council in writing. As required by d), Council will advise, in writing, the owners of the property from which the overlay will be removed.			
	Transpower has provided a shapefile for the removal of the National Grid Corridor Overlay from the currently affected properties. The updated map has been reviewed by Transpower to confirm that Council is uplifting the correct sections of the National Grid Corridor Overlay from the AUP GIS viewer maps.			
	The effect of the removal of the overlay from the AUP GIS viewer maps is considered neutral. However, there is a benefit to the321 properties identified in Attachment 2 as the properties will no longer be subject to the provisions of Chapter D26 National Grid Corridor Overlay.

## RE: NATIONAL GRID CORRIDOR OVERLAY UPLIFT - ALBANY-HENDERSON TRANSMISSION LINE

Transpower has recently completed works to dismantle a transmission line between Albany and Henderson, therefore the corresponding National Grid Corridor Overlay that applies to this transmission line is no longer required and can be uplifted. The enclosed map shows where the line was located.

Chapter D.26.4 Auckland Unitary Plan (Operative in Part) (AUP(OP)) includes information on when the National Grid Corridor Overlay shown on the planning maps is to be updated. The AUP(OP) states (bold added for emphasis):

The National Grid Corridor Overlay rules cease to have effect and the maps can be updated accordingly where:

- (a) a National Grid line or part of a line is dismantled, undergrounded or moved; or
- (b) a National Grid substation is dismantled, or the site boundary of a National Grid substation reduces in size;

and the following has occurred:

- (c) Transpower New Zealand Limited has advised the Council in writing; and
- (d) The council has advised owners of the property from which the overlay will be removed in writing;

This letter is Transpower's written confirmation that the Albany-Henderson 110kV transmission line has now been dismantled and the corresponding National Grid Corridor Overlay for this transmission line shown on the planning maps can be removed.


