**SUBMITTER: THE STEVEN AND SOFIA NUICH AS TRUSTEES OF THE  
NUICH FAMILY TRUST**

1. Pursuant to section 274 of the RMA, The Steven and Sofia Nuich Family Trust ("**Nuich**") hereby gives notice of its wish to be party to an appeal by NTC against a decision of Auckland Council ("**the Council**") on the Auckland combined plan, now the Auckland Unitary Plan: Operative in Part, ENV-2017-AKL-155.
2. The appeal concerns the Council's acceptance of the Independent Hearing Panel's recommendation that it approve I610.10.1. Redhills Precinct: Precinct plan 1 ("**Redhills Precinct**") on 27 July 2016, and in particular the inclusion of arterial roads amended from those which were indicated in submissions, and the provision of a new arterial connection to the Don Buck Road/ Fred Taylor Drive roundabout.
3. Nuich is not a trade competitor for the purposes of section 308C of the RMA.
4. Nuich made submissions and further submissions on the proposal, namely submissions and further submissions seeking the inclusion of a Precinct Plan for the area now known as the Redhills Precinct in the Unitary Plan.
5. Nuich has an interest in the proceedings that is greater than the interest the general public has, because UHL owns lands affected by the Redhills Precinct. These lands are as follows:
  - (a) Section 4 SO 443144 (132 – 136 Fred Taylor Drive, Whenuapai);
  - (b) Pt Lot 1 DP 45675 (138 Fred Taylor Drive, Whenuapai); and
  - (c) Lot 1 DP 136111 (140 Fred Taylor Drive, Whenuapai).
6. Nuich takes a neutral stance on the relief sought.
