

**SUBMITTER: OLGA NUICH**

1. Pursuant to section 274 of the RMA, Olga Nuich ("**Ms Nuich**") hereby gives notice of her wish to be party to an appeal by Bunnings against a decision of Auckland Council ("**the Council**") on the Auckland combined plan, now the Auckland Unitary Plan: Operative in Part, ENV-2016-AKL-232.
2. The appeal concerns the Council's acceptance of the Independent Hearing Panel's recommendation that it approve I610.10.1. Redhills Precinct: Precinct plan 1 ("**Redhills Precinct**") on 27 July 2016, and in particular the inclusion of arterial roads amended from those which were indicated in submissions, and the provision of a new arterial connection to the Don Buck Road/ Fred Taylor Drive roundabout.
3. Ms Nuich is not a trade competitor for the purposes of section 308C of the RMA.
4. Ms Nuich is a member of the Westgate Joint Venture (previously Westgate Partnership), who made submissions and further submissions on the Redhills Precinct.
5. Ms Nuich has an interest in the proceedings that is greater than the interest the general public has, because Ms Nuich owns land affected by the Redhills Precinct. This property is located at 2-4 Dunlop Road, Massey (Lot 5 DP 52123).
6. Ms Nuich takes a neutral stance on the relief sought.
