## **RADIO NEW ZEALAND LIMITED DECISION ON AUCKLAND COUNCIL DESIGNATION RECOMMENDATION**

- 1 This letter sets out Radio New Zealand Limited's (*Radio NZ*) decision, as requiring authority, on the Auckland Council recommendations on designations that were notified on 19 August 2016.
- 2 Radio NZ is the requiring authority for two designations in Auckland:
  - 2.1 7300 Telecommunication and Radiocommunication Facilities, Corner of Triangle and Lincoln Road, Henderson; and
  - 2.2 7301 Telecommunication and Radiocommunication Facilities, 2-12 Selwood Road, Henderson

*(the designations)*

### **Summary**

- 3 The Council's decision recommended that the following changes to the designations be accepted:
  - 3.1 change of the address of Designation 7300 to more accurately reflect its location; and
  - 3.2 addition of a 'c' to indicate paragraph 2(c) of Designation 7301.

### **Radio NZ decision**

- 4 Radio NZ accepts the Council's recommendations on the designations, and does not wish to make any further modifications.
