NOTICE OF REQUIREMENT BY REQUIRING AUTHORITY FOR A DESIGNATION

Transpower New Zealand Limited ('Transpower') gives Notice of a Requirement for a designation for a network utility project. The designation is required for the purpose of a protective designation for the proposed cable termination structures, underground spans and ancillary structures of the Otahuhu-Whakamaru A & B 220kV transmission lines (OTA-WKM A & B), which were authorised through resource consents LUC60320180 and LUC60320180-A (attached as Appendix C and D to the Assessment of Environmental Effects).

The site to which the requirement applies is as follows:

The land to which the requirement applies is within the Flat Bush sub-precinct C development area. The sites are legally described as follows.

The land is owned by Greerton Holdings Limited, Green City Developments Limited, Murphys Park Development LP and Vista Estate LP where not vested as local road. Other than in the vested road, Transpower has a registered easement over the land. Copies of the certificates of title are provided in Appendix B of the attached Assessment of Environmental Effects.

The nature of the proposed restrictions that would apply are:

Designation Purpose:

National Grid Underground 220kV Cables, Cable Termination Structures and Ancillary Works – Protection Only

The proposed conditions are as follows:

Designation Conditions:

- 1. As soon as practicable following completion of construction of the underground cables, the aboveground cable termination structures and ancillary works, the requiring authority shall provide as-built plans to the Council.
- **2.** The Requiring Authority will prior to the next district plan review:
 - a. Review the width of the area designated for the project;
 - b. Identify any areas of designated land that are no longer necessary for the on-going operation, maintenance, renewal and protection of the underground cables and ancillary activities; and
 - c. Remove the designation over any surplus areas identified in (b) above and provide a plan of the final designated areas to the Council for inclusion in the Auckland Unitary Plan.

Advice Note

1. Where section 176 approvals are required by utility operators (other than the requiring authority) for works within the designation the requiring authority will provide a timely response, in order to facilitate co-ordination of section 176 approvals sought by the utility operator and the Corridor Access Request process.
